



A Local Law amending Chapter 164 of the Code of the Town of Warwick in relation to various sections thereof as specified below.

Be it enacted by the Town Board of the Town of Warwick, Orange County, New York, as follows:

Section 1 – Section 164-73. C. Filing deadline. shall be amended to substitute “January 1, 2015” in place of the current “January 1, 2014” therein.

Section 2 – Section 164-73. D. Construction deadline. shall be amended to substitute “four years” in place of the current “three years” therein.

Section 3. – This Local Law will take effect upon the filing of same with the New York State Secretary of State.


