Dear Planning Board,

The principals of Warwick Valley Winery hereby request approval for a public assembly permit for the upcoming season. The purpose of the permit would be to host wine and music festival for the dates of July 27th and 28th and August 17th and 18th on the winery premises located on 114 Little York Rd, Warwick, NY. We will anticipate between 800 to 900 people and between 350 and 450 cars each day. The hours of the festival are from 12:00am to 5pm. The property is owned by Dr. Joseph Grizzanti. Please see the attached map of the property for details on parking, event location, sanitary sewage, etc.

As per request, we have provided you with the following information pursuant to the application procedure.

- There will be an entry fee of \$10 or \$15 paid for admission.
- We will notify the town police, fire and ambulance departments the details of the event.
- We will have adequate garbage disposal on the premises provided by Marangi Waste Management.
- The home of Dr. Joseph Grizzanti will be made available to any person needing immediate medical treatment in the case of an emergency.
- No camping or overnight facilities are to be made available to the public.
- No soot, cinders, smoke, noxious acids, fumes, gases, unusual odors or loud/excessive noises shall be permitted to emanate beyond the property line of the assembly.
- The winery will have six portable toilets on site provided by Rent-A-John
- The water supply for the event will be provided by a privately maintained well water system inspected by the Orange County Department of Health.
- Farm Family Insurance, as our primary insurance carrier, has named the Town of Warwick as additionally insured. (see attached)
