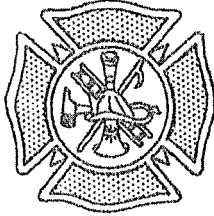

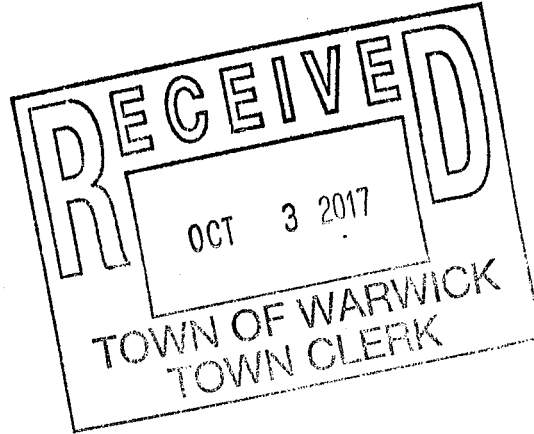

Note:

It should be noted that the Fire District does not receive its tax payment from the Town until the end of February or the beginning of March each fiscal year. In order to have sufficient unrestricted unappropriated cash on hand to fund operations for the period prior to receipt of its annual tax payment, the Fire District needs to maintain an unreserved unappropriated fund balance of at least 2 months of operating expenses. The above projection indicates that this level will be maintained.
