PLEASE TAKE NOTICE that the Annual Election of the Greenwood Lake Joint Fire District will take place on December 12, 2017, between the hours of 6:00 P.M. and 9:00 P.M. at the at the District Office located at 2 Sterling Road, Greenwood Lake, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2018 and ending December 31, 2022; and

To vote on the following proposition:

“SHALL THE GREENWOOD LAKE JOINT FIRE DISTRICT BE AUTHORIZED TO SELL THE DISTRICT OFFICES LOCATED AT 2 STERLING ROAD, GREENWOOD LAKE, NEW YORK FOR A SUM IN EXCESS OF FIFTY THOUSAND (\$50,000.00) DOLLARS?”


