

SUPERVISOR DWYER – Thank you. Just a general highlight, so this also includes our recycling district which we saw an increase of 17.22% which is approximately \$190,000 increase and cumulatively we were able to keep the special districts to 3.72% increase overall and that recycling increase is factored into this so overall some districts went down, some districts went up minimally but the major impact was our recycling contract which we have no control over. We provide recycling and the contract increased by 17.22% this year.

There were no public comments for or against this public hearing from the residents or the Town Board.
