Beginning February 14, New Yorkers with comorbidities and underlying conditions can make vaccine appointments at state-run sites for appointments starting February 15.

Eligible conditions covered include cancer, chronic kidney disease, diabetes, severe obesity, heart conditions, liver disease, and others. New Yorkers must provide proper documentation to show they have comorbidities or underlying conditions.

New York state has now administered over 2.1 million vaccine doses. While the federal government has increased New York's weekly doses by more than 20 percent over the next three weeks, our supply remains limited and appointments continue to fill up quickly.

Starting Thursday, February 11, the White House will begin shipping about 1 million COVID-19 vaccine doses a week directly to thousands of pharmacies, including select CVS and Walgreens locations, nationwide. Scroll down to see which local entities are expected to receive vaccine shipments. This list is subject to change, so be sure to check your pharmacy website to confirm your eligibility and schedule an appointment.

Scheduling An Appointment

For up-to-date information on current availability of the vaccine in New York State, please visit the NYSDOH "Am I eligible" page. You may also call your local health department, pharmacy, doctor, or hospital for additional information and to schedule appointments where vaccines are available.

While appointments may fill quickly, I urge you to continue to check your eligibility status and frequently visit the website to secure an appointment as they become available.

CVS and Walgreens will be offering COVID-19 vaccines in New York starting this Friday.

Appointments at CVS will be made available for scheduling starting Thursday, February 11. There are no walk-in appointments, and New Yorkers must register to make appointments.

In order to facilitate orderly distribution of the COVID-19 vaccine, the Orange County Health Department is asking residents to complete the Vaccination Information Request Form. Once you've done so, your information will be added to an Orange County, New York mailing list, and you will receive updates via email, phone, and/or postal mail from the County when the vaccine becomes available.
