

INTRODUCTORY LOCAL LAW # 2 of 2025

A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C

Be it enacted by the Town of Warwick in the County of Orange, State of New York as follows:

Section 1. Legislative Intent

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Warwick, County of Orange, State of New York (hereinafter "Warwick") pursuant to General Municipal Law § 3-c, and to allow Warwick to adopt a town budget for (a) town purposes and (b) any other special or improvement district governed by the Town Board for the fiscal year 2012 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3-c, which expressly authorizes the Town Board of the Town of Warwick to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Warwick is hereby authorized to adopt a budget for the fiscal year 2018 that requires a real property tax levy in excess of the limit specified in General Municipal Law, §3-c.

Section 4. Severability.

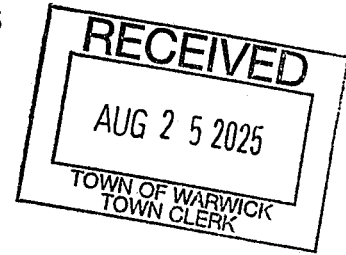
If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.

Orange County Executive Steve Neuhaus Announces Major Progress at Former Camp LaGuardia Site

Orange County Executive Steve Neuhaus announced major progress in the County’s plan to transform the long-neglected Camp LaGuardia property into a vibrant new County park for residents and visitors.

The Orange County Legislature recently authorized a \$600,000 supplemental appropriation to the 2025 County Budget for the Department of Parks, Recreation, and Conservation. These funds will support engineering and design for recreational improvements at the 258-acre site, located on the border of Chester and Blooming Grove.

This will be Orange County’s first new park since Thomas Bull Memorial Park was initiated in 1965. Once complete, Camp LaGuardia Park will be a major destination for outdoor recreation and community gatherings, while preserving the site’s historic significance.

“Camp LaGuardia has been part of Orange County’s story for generations, and it’s time we give this property a new chapter that promotes activity, recreation, and opportunity,” said Neuhaus. “This investment in design and engineering is a giant step forward. This park will rival any in the region, connect our rail trail network, and stand as a symbol of progress and pride for Orange County.”

The site’s history dates to 1934, when it was transferred to New York City’s Welfare Department and named Camp Greycourt. Initially housing more than 600 unemployed men during the Great Depression, it was renamed Camp LaGuardia in 1935 by then-Mayor Fiorello La Guardia’s office. It became a 1,000-bed homeless shelter before closing in 2007.

Orange County purchased the property in 2007 for \$8.5 million. Several private redevelopment proposals failed, leaving the site largely abandoned for more than a decade.

In 2020, the County Planning Department secured \$28 million in federal and state funding to acquire and construct the 10-mile Schunemunk Rail Trail, which will connect directly to the County’s popular Heritage Trail at the Camp LaGuardia site.

Travis Ewald, Commissioner of Orange County’s Department of Parks, Recreation, and Conservation added, “The Parks Department is grateful for the vision of County Executive Neuhaus and the support of the County

Legislature to help bring this exciting new park to fruition for Orange County residents and visitors to enjoy for many years to come. It is a terrific investment in quality of life, and I'm excited to be a part of it."

Recent progress:

- Removal of most dilapidated structures, with selective preservation for future use
- Clearing and grading for greens, playgrounds, and trails
- Construction of the first two-mile phase of the Schunnemunk Rail Trail
- Removal of most barbed wire fencing to open the property for recreational access

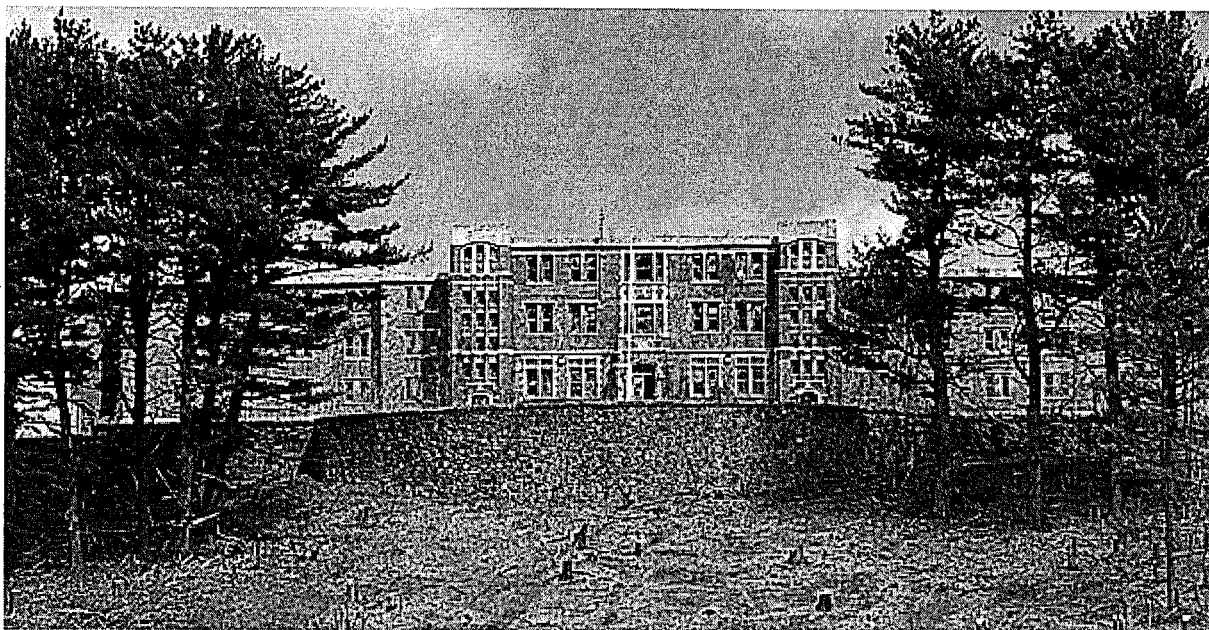
Recognizing the opportunity to create a regional park hub, the County Executive and Legislature began planning the transformation. "This is about connecting communities and investing in our quality of life," said Neuhaus. "We're moving full speed ahead, and I'm excited to see Camp LaGuardia transformed into a place where families will make memories for generations."

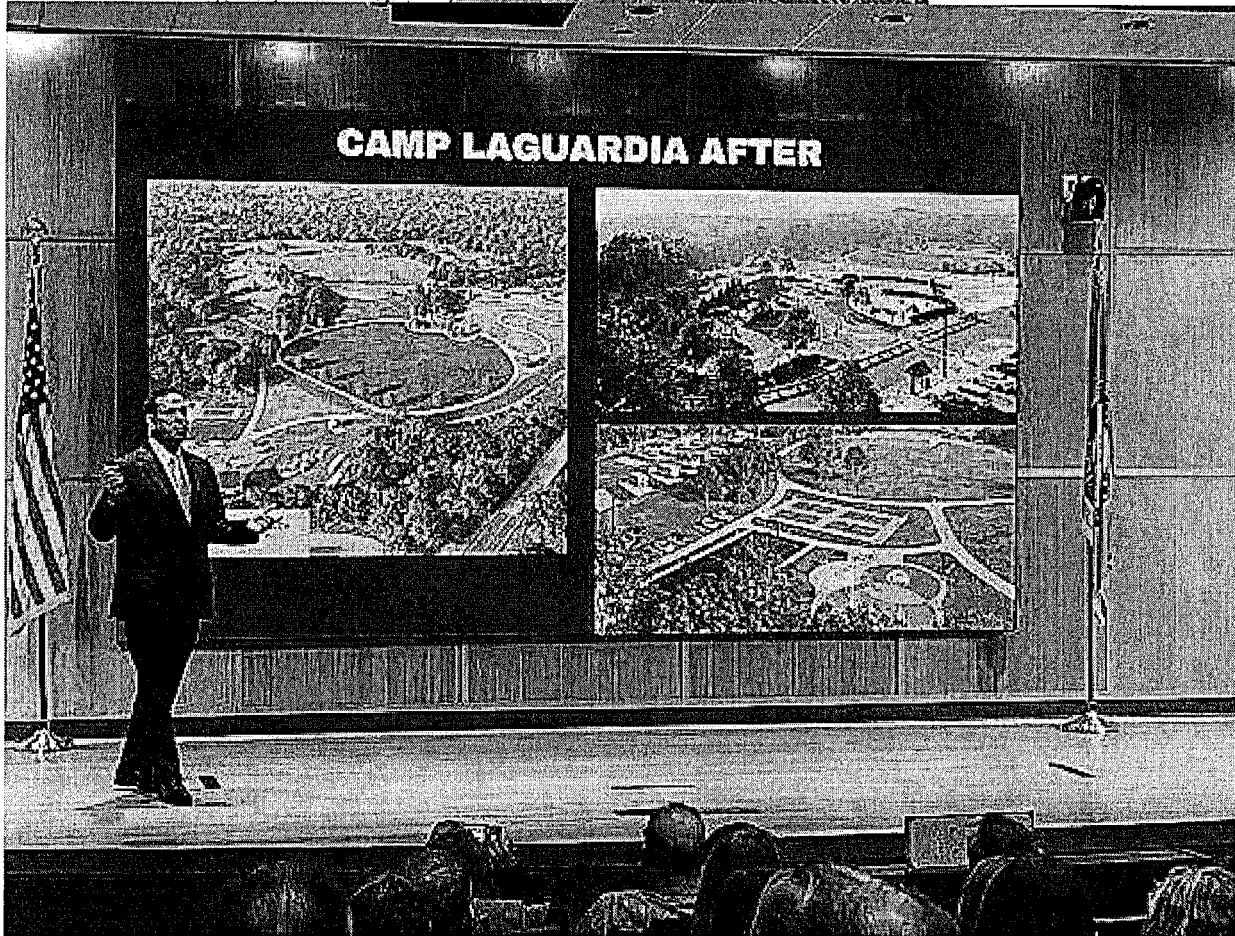
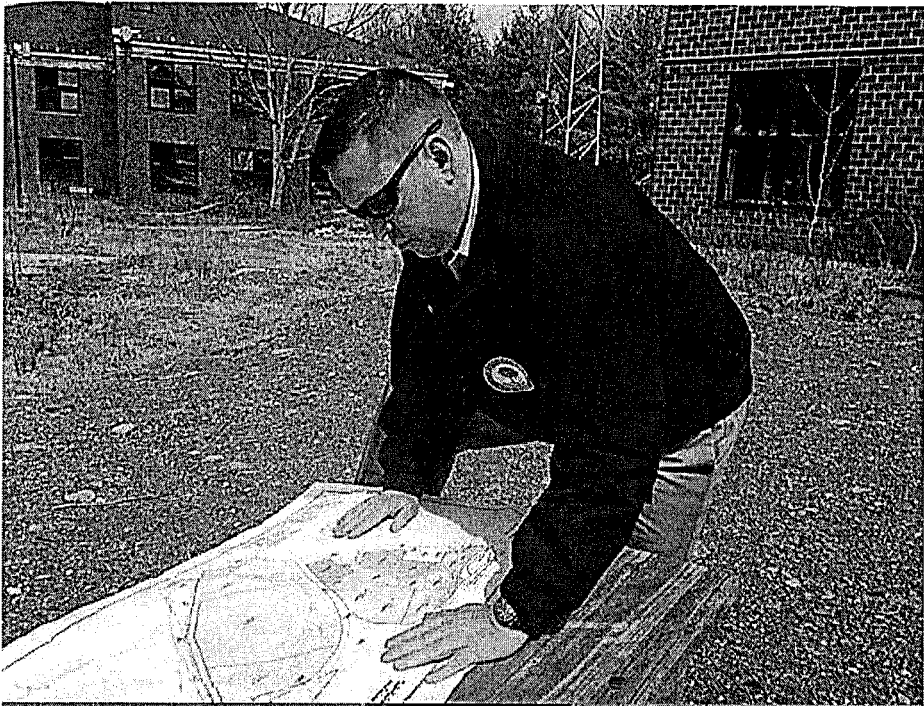

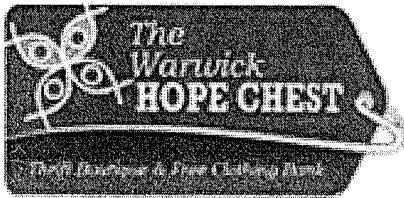

We are pleased to announce the fourth *Hazardous Waste and Safe Scripts Collection Event* of 2025, which will take place in New Hampton on **Friday, September 26th**, for CESQGs, and on **Saturday, September 27th**, for Orange County residents. The Friday, September 26th event is for school districts, municipalities, businesses, and farms, otherwise known as Conditionally Exempt Small-Quantity Generators (CESQGs). The Saturday, September 27th event is for Orange County residents with a valid ID, showing an Orange County address. Both the Friday, 9/26, and Saturday, 9/27, event will take place at the Orange County Transfer Station #1 Maintenance Garage, accessed by the service entrance (across from the entrance to the Mid-Hudson Psych. Center), located at 21 Training Center Lane in New Hampton.

All CESQGs ***MUST*** pre-register for the **Friday, September 26th** event at OCTS #3 by **NO LATER THAN C.O.B. FRIDAY, SEPT 12**. If you have acceptable materials (wet latex/water-based paints are also now accepted) and are interested in participating, please complete both pages of the attached registration form and email to esiljkovic@orangecountygov.com, or send via fax to (845) 291-4570. These forms can also be found on the EF&S Hazardous Waste webpage, at the following link: <https://www.orangecountygov.com/449/Household-Hazardous-Waste>.

IMPORTANT INSTRUCTIONS

On your registration, please indicate the QUANTITY of each material you plan on bringing - specifically the number of containers and volume of each container - on the first page, and on the second page, please include the AGGREGATE WEIGHT of said materials. NOTE: Unsigned registrations and registrations containing over 220 lbs. of materials will be rejected. Multiple registrations for one site can be submitted.

Your registrations will be sent to our vendor, MXI Environmental Services, who will then provide a quote based on your submission during the week before the event, providing you time to process purchase orders or checks.

Also attached is a JPEG of the flyer for the Saturday, September 26 event for residents. Registration for residents is not required; however, commercial quantities of materials will not be accepted. No businesses, municipalities, or school districts are permitted to bring materials to the event for residents. Please note that this event will take place from 9 AM to 3 PM. 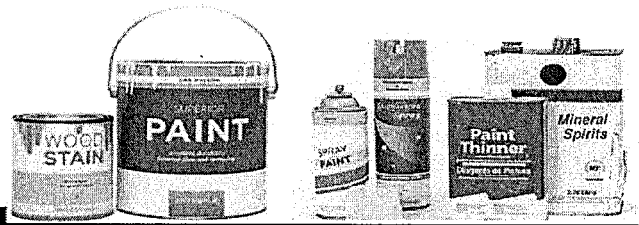

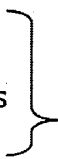

CONDITIONALLY EXEMPT SMALL QUANTITY GENERATOR CERTIFICATION

I hereby certify that I am a generator of hazardous waste within the State of New York and that because of the small volume of hazardous waste generated and/or stored, I qualify for conditionally exempt small quantity generator status.

I understand that in order for conditionally exempt small quantity generator status, I must meet all three of the following conditions:

1. Generate less than 1 kg/month (2.2 pounds) of acute hazardous waste (as defined by 6 NYCRR Part 371), and never store more than this amount on site at any time; and
2. Generate less than 100 kg/month (220 pounds) of all other hazardous waste (as defined by 6 NYCRR Part 371), and never store more than 1000 kg/month on site at any time.
3. Transport a maximum of 220 lbs of hazardous waste at one time.

Only if I am a farmer, I realize that I may store up to 1000 kg. (2200 pounds) of non-acute hazardous waste pesticides on my farm without losing my conditionally exempt status, provided that these wastes are brought to a household hazardous waste collection program.

I further understand that if, in the future, I exceed the quantity limitations described above, I will become subject to additional regulation as a hazardous waste generator and will no longer be eligible to participate in this type of collection program.

I certify that I have the authority to make these statements on behalf of my farm or business. Also, I, the undersigned, do hereby certify that the items brought for collection came from my farm or business located in Orange County.

Orange County Executive Neuhaus Launches Life-Saving Naloxone Map to Combat Overdose Crisis

Orange County Executive Steven M. Neuhaus along with the Orange County Departments of Health and Mental Health have announced the launch of a new, free Naloxone (Narcan®) Map and Information Page, now available to the public. This interactive online tool provides real-time locations of Naloxone boxes and Opioid Overdose Prevention Program (OOPP) sites throughout the County.

“This is about putting life-saving tools directly into the hands of our residents,” said Neuhaus. “We know that in an overdose situation, every second matters. By making it easier for people to find and access Naloxone, we’re giving our community a fighting chance to save lives, protect families, and turn the tide in the battle against opioid abuse.”

What is Naloxone (Narcan)?

Naloxone is a life-saving medication designed to rapidly reverse opioid overdoses, including those caused by fentanyl, heroin, and prescription painkillers. Easy-to-use and available in nasal spray form, Naloxone can restore normal breathing within 2–3 minutes and poses no harm if administered to someone who is not overdosing.

“Orange County’s collaborative spirit is saving lives,” said Lacey Trimble, Commissioner of the Orange County Departments of Social Services and Mental Health. “Making Naloxone easily accessible means bystanders can act quickly in an overdose emergency, whether it’s due to addiction or accidental opioid use. This is a vital step in our ongoing work to prevent overdoses and support recovery.”

Why It Matters:

Opioid overdoses continue to impact families and communities across Orange County. This new, interactive map empowers residents to locate free Naloxone kits quickly, access overdose prevention resources, and

become part of the solution. Every second matters in an overdose situation and having Naloxone within reach can mean the difference between life and death.

It is safe to administer Naloxone even if the person is not experiencing an opioid-related overdose. This makes it an essential tool in any emergency involving unresponsiveness or breathing issues. 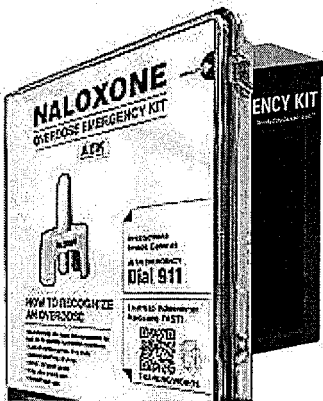



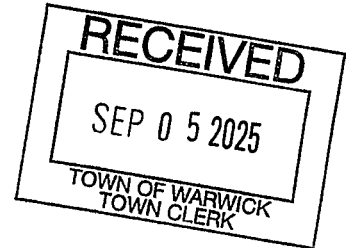
