Bob Krahulik: The house is located on a private road. Before a building permit could be issued for any construction on a private road, 280-a approval is required. It would be up to the Board or not if the house is accessible. Most importantly is it accessible by emergency service vehicles? We have granted many approvals on this road. I don't think conditions have gotten much worse or better. Historically the Board has considered emergency access adequate.

Chairman Astorino: Do any Board members or Professionals have any further comments or questions?

Mr. McConnell: I have a question regarding Comment #14 the Applicant requesting a waiver for the Surveyor to certify that iron rods have been set at all property corners. Given that this backs up to Longhouse Creek, Brian maybe you could tell me that the creek has shifted. I know that I sit on a creek. It is always getting ready to change its course. Have you identified as to where the pins are located?

Brian Friedler: There are already pins located up on the fronts of the lot to show where the corners are but not way up on the hill. On Buttermilk Falls Road there are definitely pins there. I don't know if they are way up on the hill. It is a long lot that goes way up
