Supervisor Sweeton – The purpose of the hearing is to consider replacing our current provisions we had for our partial tax exemption for Volunteer Fire Fighters. The State of New York passed new legislation the beginning of the year and it requires municipalities to revisit and replace the current policies that they have. The intent is the local law that's before the Board would provide this partial exemption up to 10% for Volunteer Fire Fighters and EMS. The goal is to keep the volunteer services alive, so the taxpayers don't have to provide that in a paid service. All the studies show the volunteer services save the taxpayer money, so this local law will add provisions for line of duty death for volunteers, there's requirements for the volunteer service whether it's fire or EMS to report the service that the volunteers do provide. I will now open it up for public comment if you would like to make comment on that legislation, please come to the podium give us your name and we will take that testimony.

Supervisor Sweeton – We will take written comment on the local law for 10 days and potentially enact on this enactment in October.
