

LEGAL NOTICE: The Clerk read the legal notice, which was duly published in the Warwick Valley Dispatch on November 1, 2023. (Copy of this legal notice is printed at the end of these minutes.)

Supervisor Sweeton – The Special Districts are only for residents who benefit from those special districts and only those residents pay these costs. We have waters districts, sewer districts, our recycling contract, which the Village of Greenwood Lake and the Village of Florida don't participate in, they have their own. The Ambulance Corps., we contract with them for their services and they are included in the Special District budget. Fire Districts are listed in the budget and they are independent and simply reflect what their boards have passed as their operating budgets. The new addition would be the Hillside Water District, which is a small district that the Town Board had a hearing on and met with residents. It was a private system that we can save the residents close to eight or nine hundred dollars a year by taking it over and operating it. It is operated now by our current water contractor, so it should be seamless to take it over and it benefit those residents.

There were no public comments for or against this public hearing from the residents or the Town Board.
