MIKE DONOVAN – News Media, Orange & Rockland Utilities, and Inc. Memo received July 13, 2023 regarding a warning to customers about potential Gift Card Fraud. The typical scam scheme goes this way: Thieves posing as O&R employees call unsuspecting customers and threaten them with the immediate shut off of their electric service if they don't pay phony O&R bills with Green Dot or other prepaid debit cards. Here are two big reasons not to believe any thief who makes a shutoff threat:

NO DEBIT CARDS - O&R does not accept bill payment for electric and gas utility bills by Green Dot or any other prepaid debit cards. Never has.

• NO IMMEDIATE SHUTOFF - Disconnecting O&R electric or gas service for non-payment of bills involves a multi-step process – including written communications from O&R to the customer over a period of several days, or even weeks – not hours. That

process is regulated by the NYS Public Service Commission and NJ Board of Public Utilities.

So, if someone calls you, says they are an O&R employee and threatens to shut off your electric or gas service that day if not immediately paid through a prepaid debit card, remember these tips:

- Hang Up Disengage so you're not further subjected to the thief's high-pressure "sales pitch."
- <u>Text Scam</u> After you hang up on them, the more aggressive thieves will try to repeat their shutoff threat by texting you. Ignore the threat. They are thieves.
- <u>Don't Hit "REDIAL"</u> The caller ID screen on your phone for the thief's call may read "Orange and Rockland Utilities," but that's a hi-tech bogus copy of the utility company's number. That's not O&R. Do not redial, and don't call the number that the caller gives you to call them back. That will reconnect you to the thief.
- <u>Fast Track</u> If you are unsure about whether you have an overdue balance on your O&R bill, the fastest way to find out is to log onto your account through <u>oru.com/myaccount</u> to review your latest account information. You also can call O&R's automated phone system at 1-877-434-4100. Have your Orange and Rockland account number ready and follow the automated phone prompts to check your balance.
- Check the I.D. If you are contacted by someone in-person or on the phone who says they represent O&R and you wish to verify their identity either ask for their photo ID card, if they are at the door, or get a call-back number if they are on the phone, and call O&R at: this new number 1-833-460-7059 during business hours Monday Friday 8 a.m. 4:30 p.m. or 1-877-434-4100 O&R's Customer Service Department off hours to verify their identity and the nature of their business with you. O&R employees and vendors are trained to cooperate with this request and are instructed to comply with a customer identity verification request.

Remember, if you are feeling threatened or otherwise uncomfortable about your security during the exchange, immediately report the incident to your local police department at 911.

Be it enacted by the Town Board of the Town of Warwick as follows:

#### TOWN OF WARWICK

#### INTRODUCTORY LOCAL LAW NO. 4 OF 2023

A LOCAL LAW ESTABLISHING A SIX-MONTH MORATORIUM PROHIBITING THE REVIEW AND APPROVAL OF CLEAN RENEWABLE ENERGY TECHNOLOGY BUSINESSES DEVOTED TO RESEARCH, EDUCATION, DISTRIBUTION OR APPLICATION OF TECHNOLOGICAL INNOVATION IN ALTERNATIVE ENERGY USES IN THE TOWN OF WARWICK

Be it enacted by the Town Board of the Town of Warwick, County of Orange, State of New York as follows:

#### Section 1. Title.

This Local Law shall be referred to as "A LOCAL LAW ESTABLISHING A SIX-MONTH MORATORIUM PROHIBITING THE REVIEW AND APPROVAL OF CLEAN RENEWABLE ENERGY TECHNOLOGY BUSINESSES DEVOTED TO RESEARCH, EDUCATION, DISTRIBUTION OR APPLICATION OF TECHNOLOGICAL INNOVATION IN ALTERNATIVE ENERGY USES IN THE TOWN OF WAR WICK".

#### Section 2. Definitions.

"Code" means the "Code of the Town of Warwick".

"Town" means the Town of Warwick.

"Town Board" means the Town Board of the Town of Warwick.

"Town Clerk" means the Town Clerk of the Town of Warwick.

"Clean Energy Business" means Business Use No. 53 set forth in 164 Attachment 1, § 164-40M, Table of Use Requirements of the Zoning Law of the Town of Warwick.

#### Section 3. Legislative Findings, Purpose and Intent.

The Town Board has determined that the Clean Energy Business regulations as written in the Zoning Law lack the specificity sufficient to oversee the approval and operation of such uses, including but not limited to Battery Energy Storage, so as to protect the public health, safety and welfare, and as certain revisions to the Zoning Law may be required to afford such protections.

Pursuant to the statutory powers vested in the Town to protect the health, safety and welfare of its residents, the Town Board of the Town of Warwick hereby declares a six-month moratorium on the submission, processing and/or approval of any applications of Clean Energy Business use, including but not limited to the placement of any Battery Energy Storage, pursuant to applicable provisions of the Zoning Law pending the Town Board's completion and

adoption of certain amendments to the Zoning Law that through their review are found to be necessary to better implement the purpose and intent of said law.

#### Section 4. Scope of Controls

During the effective period of this Local Law, no applications or approvals for the establishment of Clean Energy Businesses shall be accepted or processed by any Departments of the Town, and no approvals for such use shall be issued by any department or Board of the Town as provided for in the Zoning Law.

#### Section 5. Term.

The moratorium imposed by this Local Law shall be in effect for six (6) months from the effective date of this Local Law.

#### Section 7. Penalties.

Any person, firm or entity that operates a Clean Energy Business without required approvals shall otherwise violate any of the provisions of this Local Law shall be subject to:

- A. Such penalties as may otherwise be provided by applicable local laws, ordinances, rules, regulations of the Town for violations; and
- B. A fine not to exceed \$500.00 per day from the date that any action is taken in contravention of this local law, together with any other civil remedies available at law; and
- C. Injunctive relief in favor of the Town to cease any and all such actions which conflict with this Local Law and, if necessary, to remove any such uses that may have taken place in violation of this Local Law.

Any application accepted or approval granted in violation of this Local Law shall be null and void.

#### Section 9. Severability.

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town Board of the Town of Warwick hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

#### Section 10. Repeal.

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

#### Section 11. Effective Date.

This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

To all Orange County Licensed Solid Waste Haulers:

Please be advised that per Local Law No. 2 of 1989, solid waste generators are required by law to source separate recyclable commodities from refuse. In order for source separation of recyclables to be effective in providing materials ready for markets, there must be minimal contaminants in the recycling streams. A major source of contamination are plastic bags and bagged recyclables. While well intentioned, bagged recyclables cause problems at the materials recovery facilities downstream and the materials inside the bags are never recovered.

Please ensure that all solid waste generators in your service area are aware that plastic bags are not accepted, and the bagging of recyclable materials is not an effective practice to ensure the recycling of curbside recyclable materials. <u>All recyclable materials are to be deposited loosely into the containers</u>.

Attached you will find our "Do One Thing" postcard on bagged recyclables, as well as a flyer containing a full list of accepted materials in Orange County's Single Stream Recycling.







### ORANGE AND ROCKLAND UTILITIES: NEW LAW TO GUARD AGAINST GIFT CARD SCAMS

Businesses are Required to Post a Warning About Potential Gift Card Fraud

PEARL RIVER, NY, July 12, 2023, 6:30 am – Orange and Rockland Utilities today advised its customers that New York State has adopted a new consumer protection law designed to help shield NYS consumers from potential gift card scams.

The new law requires all businesses selling gift cards to display a notice at or near where any gift cards or gift certificates are displayed or sold to alert consumers about gift card fraud.

Requesting gift cards as payment has become increasingly popular with thieves as funds are nearly impossible to trace. According to the Federal Trade Commission in 2022, nearly 65,000 consumers filed a complaint related to gift card scams, equating to a total loss of \$228.3 million.

With the number of gift card scams on the rise, it's more important than ever to educate consumers so they know that **gift cards should only be used for gifts, not to make payments.** This new law requiring warning signage where gift cards are displayed or sold will help to reduce the success rate of these thieves and protect consumers' hard-earned money.

The typical scam scheme goes this way: Thieves posing as O&R employees call unsuspecting customers and threaten them with the immediate shut off of their electric service if they don't pay phony O&R bills with Green Dot or other prepaid debit cards.

Here are two big reasons not to believe any thief who makes a shutoff threat:

- NO DEBIT CARDS O&R does not accept bill payment for electric and gas utility bills by Green Dot or any other prepaid debit cards. Never has.
- NO IMMEDIATE SHUTOFF Disconnecting O&R electric or gas service for non-payment of bills involves a multi-step process – including written communications from O&R to the customer over a period of several days, or even weeks – not hours. That process is regulated by the NYS Public Service Commission and NJ Board of Public Utilities.

So, if someone calls you, says they are an O&R employee and threatens to shut off your electric or gas service that day if not immediately paid through a prepaid debit card, remember these tips:



- Hang Up Disengage so you're not further subjected to the thief's high-pressure "sales pitch."
- <u>Text Scam</u> After you hang up on them, the more aggressive thieves will try to repeat their shutoff threat by texting you. Ignore the threat. They are thieves.
- <u>Don't Hit "REDIAL"</u> The caller ID screen on your phone for the thief's call may read
  "Orange and Rockland Utilities," but that's a hi-tech bogus copy of the utility company's
  number. That's not O&R. Do not redial, and don't call the number that the caller gives you to
  call them back. That will reconnect you to the thief.
- Fast Track If you are unsure about whether you have an overdue balance on your O&R bill, the fastest way to find out is to log onto your account through <a href="https://example.com/myaccount">oru.com/myaccount</a> to review your latest account information. You also can call O&R's automated phone system at 1-877-434-4100. Have your Orange and Rockland account number ready and follow the automated phone prompts to check your balance.
- Check the I.D. If you are contacted by someone in-person or on the phone who says they represent O&R and you wish to verify their identity either ask for their photo ID card, if they are at the door, or get a call-back number if they are on the phone, and call O&R at: this new number 1-833-460-7059 during business hours Monday Friday 8 a.m. 4:30 p.m. or 1-877-434-4100 O&R's Customer Service Department off hours to verify their identity and the nature of their business with you. O&R employees and vendors are trained to cooperate with this request and are instructed to comply with a customer identity verification request.

Remember, if you are feeling threatened or otherwise uncomfortable about your security during the exchange, immediately report the incident to your local police department at 911.
