### ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY TO AMEND AND SUPPLEMENT CERTAIN PORTIONS OF CHAPTERS 420 "LAND USE PROCEDURES" AND 500 "ZONING" SECTION 500-90 FARM ANIMALS OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP

WHEREAS, upon discussion the Township Council of the Township of West Milford finds it desirable and necessary to provide certain clarifications to the standards regulating fowl and farm animals to ensure proper and efficient implementation of same.

**NOW, BE IT ORDAINED** by the Township Council of the Township of West Milford, County of Passaic, State of New Jersey, that the Land Development Ordinance shall be amended and supplemented as provided herein.

SECTION 1. Chapter § 420 Land Use Procedures § 420-6 Definitions FOWL

Domesticated chickens, ducks, peahens, and the like, excluding roosters and male chickens of any age.

#### **SECTION 2.** § 500-90. Farm animals.

- A. Notwithstanding any other provisions of this chapter, farm animals shall be housed and kept in a manner which will not constitute a public nuisance.
- B. A minimum tract for the keeping of farm animals shall be:
  - (1) One acre for the keeping of horses, except as provided in Subsection B(5) of this section. The number of horses permitted shall be determined by the size of the accessory structure(s) housing the animals, using 100 square feet of roof area per animal as the criteria for determining the number of horses permitted on the property. A minimum of 32 square feet of roof area shall be required per animal.
  - (2) One acre for the keeping of cows, sheep, pigs and goats, except as provided in Subsection B(5) of this section. No more than one animal shall be kept per acre of lot area.
  - (3) One acre for the keeping of poultry and fowl as defined in § 420-6, except as provided in Subsection B(5) of this section and subject to the following standards:
    - [a] There shall be allowed a maximum amount of 12 fowl, as defined in § 420-6, allowed on lots of less than one acre.
    - [b] The keeping of roosters (mature male chickens) and cockerels (young male chickens) is prohibited.
    - [c] No more than 32 animals shall be kept per acre of lot area.
    - [d] Fowl shall be provided with a fully enclosed shelter (coop) and a run or fenced enclosure, with the following requirements:
      - [1] Portable (not permanently affixed to the ground) coops do not require a Zoning Permit Application. Permanent coops must submit a Zoning Permit Application.
      - [2] Coops and runs or fenced enclosures shall meet the Accessory Structure setback requirements per § 500-12 and must be a minimum of 25 feet from any residential dwelling.
      - [3] Coops and shelters shall have a maximum permitted height of twelve (12) feet.

- [e] The shelter and enclosures shall remain in good repair and in a clean and healthy condition, free from the accumulation of waste, free from noxious or offensive odor, and free from any condition which may breed flies or other insects. Slaughtering fowl in public view is prohibited.
- [f] Storage of manure, waste, and odor or dust producing substance shall be kept in a water-tight container, disposed of in accordance with health code and accepted agricultural practices; and such manure and waste storage shall be located at least 15 feet from any lot line and a minimum of 25 feet from any residential dwelling.
- (4) There shall be no minimal lot size for the keeping of rabbits. No more than 25 rabbits shall be kept on lots of one acre or less and no more than 75 rabbits shall be kept on lots of over one acre.
- (5) No farm animals shall be kept on one-acre lots in subdivisions of over five lots which have received major subdivision approval from the West Milford Planning Board. (6) The housing and keeping of all other farm animals is prohibited.
- C. No farm animals shall be kept unless they can be contained on the property of their owner or the agent of their owner.
- D. Any use for the keeping of farm animals prior to the adoption of this chapter shall be considered nonconforming, provided that the owner register the use with the Township Zoning Officer within 90 days of the passage of this chapter.
- E. The provisions of this section shall not apply to farms or commercial horse stables as defined in § 420-6, Definitions.
- **SECTION 3.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other section or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- **SECTION 4.** All ordinances of the Township of West Milford which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 5.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- **SECTION 6.** This ordinance shall take effect immediately upon final passage, approval and publication as required by law.
- **SECTION 7.** This Ordinance may be renumbered for codification purposes.

### ORDINANCE OF THE TOWNSHIP OF WEST MILFORD, COUNTY OF PASSAIC, STATE OF NEW JERSEY TO AMENDING CHAPTER 500-ZONING SECTION 500-68 FENCES, WALLS AND SIGHT TRIANGLES OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP

**WHEREAS**, upon discussion the Township Council of the Township of West Milford finds it desirable and necessary to provide certain clarifications to the standards regulating fences, walls and sight triangles to ensure proper and efficient implementation of same.

**NOW, BE IT ORDAINED** by the Township Council of the Township of West Milford, County of Passaic, State of New Jersey, that the Land Development Ordinance shall be amended and supplemented as provided herein.

### **SECTION 1**. Chapter § 500 Zoning § 500-68. Fences, walls and sight triangles.

- A. All permitted fences shall be situated on a lot in such a manner that the finished side of the fence shall face adjacent properties. No fence shall be erected of barbed wire, topped with metal spikes, or constructed of any material or in any manner which may be dangerous to persons or animals, except that these provisions shall not apply to farms or where necessary for the keeping of farm animals as provided in § 500-90 and except further that fences permitted for commercial and industrial uses may be topped by a barbed wire protective barrier. Moreover, notwithstanding any other provisions of this section, retaining walls which are under four feet in height, part of a larger project certified by an engineer, or on a site plan approved by the Township Engineer do not require a separate zoning or building permit application. Retaining walls over four feet in height require both a zoning and building permit application. Any Township review of the submitted request shall consider the safety and aesthetic aspects of the proposed retaining wall. [Amended 10-20-2021 by Ord. No. 2021-035]
- B. On any lot in any residential district, no wall or fence shall be erected or altered so that such wall or fence is over four feet in height in the front yard areas and six feet in height in the side and rear yard areas except: [Amended 11-4-1998 by Ord. No. 1998-19]
  - (1) A private residential swimming pool area shall be surrounded by a fence at least four feet, but no more than six feet, in height. Swimming pool areas shall be located in rear or side areas only. See § 500-86 for additional standards.
  - (2) A tennis court area, located in rear yard areas only, may be surrounded by a nonopaque fence, a maximum of 15 feet in height. The fence shall be set back from any lot line the distances required for accessory buildings in the zoning district as specified.
  - (3) Buffer areas shall meet the requirements specified in this chapter.
  - (4) Off-street parking, loading, and driveway areas shall meet the requirements specified in § 500-73.
  - (5) Where necessary for the keeping of farm animals as provided for in § 500-90.
- C. On any lot in any nonresidential district, no wall or fence shall be erected or altered so that the wall or fence shall be over three feet in height in the front yard areas and six feet in height in side and rear yard areas. [Amended 11-4-1998 by Ord. No. 1998-19]

- D. Sight triangle easements shall be required at intersections, in addition to the specified right-of-way width, in which no grading, planting or structure shall be erected or maintained except for street signs, fire hydrants, and light standards. The "sight triangle" shall be defined as that area outside of the street right-of-way which is bounded by the intersecting street lines and the straight line connecting "sight 1. Editor's Note: Amended at time of adoption of Code (see Ch. 1, General Provisions, Art. I). :1 points," one each located on the two intersecting street center lines; arterial streets at 300 feet; collector streets at 200 feet; and local streets at 90 feet. Where the intersecting streets are both arterials, both collectors, or one arterial and one collector, two overlapping sight triangles shall be required, formed by connecting the "sight point" noted above with a "sight point" 90 feet on the intersecting street. Such easement dedication shall be expressed on the site plans as follows: "Sight triangle deeded for the purposes provided for and expressed in the Land Development Ordinance."
- E. In all zone districts, any walls must be located at least one foot from any property line. Walls are prohibited from being placed within any right-of-way.

**SECTION 2.** All ordinances of the Township of West Milford, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 4.** No provision of this Ordinance shall be construed to impair any common law or statutory cause of action, or legal remedy there from, of any person for injury or damage arising from any violation of this Ordinance or from other law.

**SECTION 5.** This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.

**SECTION 6.** This Ordinance may be renumbered for codification purposes.

### District Attorney Hoovler and Veterans Suicide Prevention Coalition Thank Businesses and Others Who Helped Distribute Materials to Prevent Veterans from Harming Themselves

District Attorney Hoovler joined Hudson Valley VA Healthcare System to create a Coalition to Prevent Veterans from Committing Suicide

Over 650 Orange County Businesses, Events and Organizations Aided in Distribution of Veterans Administration Anti-Suicide Materials

Orange County District Attorney David M. Hoovler, and Carl LoFaro from the Hudson Valley VA Health Care System, announced that the Orange County Coalition to Prevent Veteran Suicide, aided by over 650 Orange County businesses, events and organizations have distributed Veteran's Administration anti-suicide materials throughout Orange County and surrounding areas. In November 2021, District Attorney Hoovler joined with the Hudson Valley VA Healthcare System to form an Orange County Veterans Suicide Prevention Coalition. Suicide numbers in Orange County are alarmingly high. Nationwide, about seventeen veterans succumb to suicide every day. Veteran suicide rates are fifty percent higher than non-veteran suicide rates. In an effort to reduce this sad statistic, the Orange County District Attorney's Office partnered with the Hudson Valley VA Healthcare System to create the Orange County Veterans Suicide Prevention Coalition.

Over the last year, the Orange County Coalition to Prevent Veteran Suicide has been visiting local stores, businesses, and organizations, in, around and near Orange County, to ask for their help in preventing veteran suicide in their communities. In addition, the Coalition has attended several events with the same message. The response was nothing short of fantastic. More than six hundred and fifty stores, events, businesses, and organizations are displaying Veteran Crisis Line resources in the form of cards, magnets, stickers, posters, coasters, pill organizers, hankies, bookmarks, and stress balls to increase awareness and promote access to this important resource for veterans in crisis. The Coalition also distributed over 4700-gun locks, an option for veterans and others to use, should they decide to, to reduce access to a firearm for the veteran during a time of crisis. Research shows that barriers between a person with suicidal thoughts and the means to carry them

out saves lives. In addition to gun locks, over 20,000 Veteran Crisis Line awareness resources were distributed before this past Veterans Day weekend to the public in our area.

Orange County District Attorney David Hoovler and Mr. Carl LoFaro of the Hudson Valley VA Health Care System remind everyone that both veteran and youth suicides are a big problem in Orange County and across the country. Fortunately, community members can be part of the solution by learning about the warning signs of a mental health crisis and how to access the 24/7 Veterans Crisis Line.

The response from Orange County's residents has been overwhelming. Orange County has the highest percentage of veterans in the Mid-Hudson region. Many businesses have already shown support for service members and veterans by giving veterans discounts. Whether they are veteran-owned and operated, like Monroe's Amendola's Pizza and Restaurant, or institutions like Benny Haven's Pub in Highland Falls, which has been serving West Point Cadets since before the Civil War, these businesses have one thing in common they all are eager to help end veteran suicide in their communities. Many Orange County businesses and organizations also have relatives or friends currently serving on active duty in the Armed Forces which is another reason for the outstanding support given to the Coalition. Government offices and law enforcement agencies have also been essential partners. Firearms dealers have been crucial partners in the distribution of gun locks to veterans wanting this resource.

"I am very proud this Veterans Day weekend that the people of Orange County have always shown such strong support for our veterans and active-duty military," said District Attorney David M. Hoovler. "When you see Veteran Crisis Line resources on a store counter, take one for yourself, and a veteran in your life, and mention it to the owner that their actions on behalf of veterans are appreciated."

Listed below, in no particular order, are some of the over 650 stores, events, businesses and organizations that are helping the Orange County Coalition to Prevent Veteran Suicide by handing out Veteran Crisis Line resources. 





If you are an employee of an entity of New York State or the United States government and you are on official New York State or federal government business and staying in a hotel or motel, you may use this form to certify the exemption from paying state-administered New York State and local sales taxes (including the \$1.50 hotel unit fee in New York City). This **does not** include locally imposed and administered hotel occupancy taxes, also known as *local bed taxes.* 

New York State governmental entities include any of its agencies, instrumentalities, public corporations, or political subdivisions.

#### Memorandum of Agreement between Jewish Family Service and the Town of Warwick Friendly Visitor Program January 1, 2023 - December 31, 2023

This agreement between Jewish Family Service (JFS) and the Town of Warwick Friendly Visitor Program (FVP) seeks to solidify the collaborative partnership between the two organizations, while preserving the rights and privileges of each organization. This agreement seeks to outline the responsibilities of each organization, in the hopes of ensuring a sound working relationship between Jewish Family Service and the Town of Warwick Friendly Visitor Program. This agreement is to be reviewed and renewed annually.

#### Jewish Family Service agrees to:

- Promote the partnership between the Town of Warwick Friendly Visitor Program and JFS which may include listing in brochures, flyers, pamphlets, news articles, social media posts, JFS website or media announcements. JFS will make available to the Town of Warwick Friendly Visitor Program all such materials.
- Provide a liaison to work with the Town of Warwick FVP coordinator and/or designee. The liaison will attend all advisory committee meetings, present neighbor activities, attend special events and share JFS communications.
- Assist the coordinator and/or designee with problematic neighbor or volunteer concerns. The JFS liaison will train the coordinator to perform new neighbor intakes and home assessments.
- JFS designated Program Coordinator or designee will partner with town coordinator and/or designee to log new requests, coordinate outreach, perform intakes and home assessments.
- Accept referrals for counseling, care giver support services, Alzheimer's and related dementias, and case management of neighbors in the Town of Warwick FVP.
- Meet with coordinator and/or designee regularly to provide additional trainings and community information.
- Provide a temporary JFS staff Program Coordinator or designee to maintain the program when the coordinator position is temporarily vacant, up to 30 days, and/or when the coordinator is on vacation or sick leave to provide continuity of services for residents of

the Town of Warwick.

- Provide necessary access and training for the coordinator to use the Volunteer Hub database. (Refresher Training Available)
- Provide mandatory trainings to all volunteers.
- In addition to the mandatory trainings, optional trainings will be offered that the volunteers are encouraged to attend quarterly.
- Conduct background checks on all new volunteers.
- Provide general volunteer liability insurance of \$1,000,000 and supplemental automobile liability insurance to all volunteers while they perform volunteer duties under the Town of Warwick FVP name. In addition, JFS will furnish the Town of Warwick with a Certificate of Insurance with the municipality named on the policy.
- Enter all volunteers and neighbors in the JFS database and track all services provided by the volunteers. As a result, JFS will provide a monthly report to the Town of Warwick Friendly Visitor advisory committee, coordinator and/or designee (by the 10<sup>th</sup> of each month for the previous month activities).
- Maintain social media sites in coordination with the coordinator and/or designee.

#### Town of Warwick Friendly Visitor Program agrees to:

- Maintain a Town of Warwick Friendly Visitor Program Advisory Committee.
- Facilitate Town of Warwick Friendly Visitor Advisory Committee meetings at a centralized location regularly (at least six meetings per year). These can also be held virtually.
- Identify and provide a Coordinator to work with JFS.
- Identify a designee to work with JFS as a liaison for the Town of Warwick.
- Promote the partnership between the Town of Warwick FVP and JFS. This may include listing Jewish Family Service in brochures, flyers, pamphlets, news articles, or media announcements for anything related to the FVP services. Any materials designed by the Town program that highlights the partnership between JFS and the Town of Warwick FVP will be shared with JFS and appropriate logos will be included.
- Post trainings and/or announcements for both the Town of Warwick FVP and JFS on the municipality page, social media pages, and property.
- Recruit volunteers and neighbors for the Town of Warwick FVP.
- Perform intakes (home assessments) on all appropriate neighbors requesting services unless operational agreement is made between JFS and the Town Coordinator in which JFS performs this task. Changes will be communicated with Town Liaison.
- Provide, if able, meeting space for the recruitment and training of volunteers. Virtual opportunities are also available when space is limited.
- Provide referrals of care recipients needing other services to JFS.
- Keep electioneering separate from all FVP outreach events.
- Provide JFS program funding within the Town of Warwick yearly budget projections

For the above services, the Town of Warwick will pay the annual amount of **<u>\$5,000</u>** which includes:

- General/Professional Liability,
- Background Checks,
- Volunteer Accident Insurance, 1,000,000 coverage with Town of Warwick being a named additional insured.
- JFS coverage when the Town Coordinator is not available,
- Volunteer Training and Volunteer Hub Training,
- re-design of Rack Cards as needed, as determined by JFS
- Access to the Volunteer Hub software for coordinating events.

#### **Additional Cost**

 Replenishment of rack cards – based on printing prices at the time of request and amount requested, Warwick is responsible for printing costs for additional marketing materials.

Each party agrees to defend and indemnify the other from all actions, claims, damages etc. which may be made against such party as a result of the negligence of the indemnifying party.

The undersigned have reviewed the above and agree to the items outlined. This agreement is in effect for one year, starting January 1, 2023. Each party may exit this agreement at any time, for any or no cause, providing that the other party is given 30 days' notice. Notice must be given in writing.







As of the effective date of this local law as stated herein, the Zoning Map of the Town of Chester shall be, and hereby is, amended to change the zoning classification of the Premises so described as 26 McBride Road, Town of Chester, County of Orange, State of New York, designated as Section 1, Block 1, Lot 82 on the Tax Map of the Town of Chester, from AR-.3 (Agricultural Residential) District to AI (Agricultural Industrial) District.






