

# Preventing Injury and Death from Shoveling and Snow Blowing

With really big snow storms – and even every day, run-of-the-mill snow falls – comes a risk of injury and even death by removing snow using shovels and snow blowers. Nationwide, snow shoveling is responsible for thousands of injuries and as many as 100 deaths each year.



So, why so many deaths? Shoveling snow is just another household chore, right? Not at all; picking up a shovel and moving hundreds of pounds of snow, particularly after doing nothing physical for several months, can put a big strain on the heart.

Pushing a heavy snow blower also can cause injury. And, there's the cold factor. Cold weather can increase heart rate and blood pressure. It can make blood clot more easily and constrict arteries, which decreases blood supply. This is true even in healthy people. Individuals over the age of 40 or who are relatively inactive should be particularly careful.

#### National Safety Council recommends the following tips to shovel safely.


- Do not shovel after eating or while smoking
- Take it slow and stretch out before you begin
- Shovel only fresh, powdery snow; it's lighter
- Push the snow rather than lifting it
- If you do lift it, use a small shovel or only partially fill the shovel
- Lift with your legs, not your back
- Do not work to the point of exhaustion

Don't pick up that shovel without a doctor's permission if you have a history of heart disease. If you feel tightness in the chest or dizziness, stop immediately. A clear driveway is not worth your life.

#### **Shoveling and Back Injury**

Snow shoveling is one of the more common causes of back injuries during the winter months. However, this type of injury is preventable if you know the best ways to remove snow without straining the back.


The following snow removal tips can help you to avoid low back injuries and pain during the snowy winter season.



#### **Pick the Right Snow Shovel**

An ergonomic snow shovel can help take some of the effort out of snow removal chores.

- A shovel with a curved handle or an adjustable handle length will minimize painful bending, requiring you
  to bend your knees only slightly and arch your back very slightly while keeping the shovel blade on the
  ground.
- A small, lightweight, plastic blade helps reduce the amount of weight that you are moving.
- If using a straight handle shovel follow these basic tips:




#### Warm Up Thoroughly

Cold, tight muscles are more prone to injury than warmed up, flexible muscles. Do your back a favor by warming up for five to ten minutes before shoveling or any strenuous activity.


- Get your blood moving with a brisk walk, marching in place, or another full-body activity.
- Then, stretch your low back and hamstrings (the large muscles in the back of the thigh) with some gentle stretching exercises.
- Limber up your arms and shoulders with a body hug that you hold for 30 60 seconds.





#### **Snow Blower Safety**

Each year, hundreds of people suffer serious damage to their fingers or hands due to the improper handling of snow blowers. Most commonly, the tips of the fingers need to be amputated, so preventing the injury initially is key.





hand. Unfortunately, the blades still can rotate when the machine is off, and these cut whatever is in their path.

Stay safe while snow blowing this season with these tips:

#### HOW TO KEEP YOUR SNOWBLOWER FROM CLOGGING

- Work at a brisk pace. The faster the blades and pace, the less likely the snow will stick.
- If heavy wet snow is anticipated, consider snow blowing several times during the snowfall.
- Some people spray the blades and chute with cooking oil spray which may help.


#### IF YOUR SNOWBLOWER CLOGS:

- Turn it OFF!
- Disengage the clutch.
- Wait five seconds after shutting the machine off to allow the impeller blades to stop rotating.
- ALWAYS use a stick or broom handle to clear the impacted snow.
- NEVER put your hand down the chute or around the blades.
- Keep all shields in place. DO NOT REMOVE the safety devices on the machine.
- Keep your hands and feet away from all moving parts.


#### REMEMBER:

- Stay focused while snow blowing.
- Wear boots with traction to avoid slipping.
- Do not drink alcohol or use narcotics before using your snow blower!

Dear Supervisor Sweeton,

At Orange and Rockland Utilities we're working hard to ensure that our electric distribution lines are properly maintained. Because interference from tree limbs is the single most frequent cause of power outages, periodic tree maintenance along overhead electric distribution wires is critically important in reducing potential power outages.

We'll soon be conducting such work in the **Town of Warwick** and I want to keep you informed of our planned activities.

As you may know, distribution lines carry electricity from the overhead lines along the streets to homes and businesses. To reduce the danger and inconvenience associated with power outages, our Distribution Line Clearance Program calls for us to cut back trees that are touching lines or which have the potential to interfere with the wires. At the same time, we remove dead trees and underbrush. Our work crews will make every effort to be in and out of the area as quickly as possible. Since this type of work is now performed on a four-year cycle, any neighborhood included this year won't be visited again for routine upkeep (except in emergencies) for approximately four years.

We want you to know our current schedule for distribution line tree maintenance. Beginning on or about <u>January 29, 2018</u> and continuing for approximately four (4) weeks, we'll perform tree trimming and removal work along the following streets <u>Long Meadow Road, Sterling Mine Road, and associated side streets.</u> Nelson Tree Service, under our supervision, has been contracted for this purpose.

Residents will be contacted via letter to be apprised of the program trimming.

We will, of course, notify you immediately if this schedule changes or if further distribution line clearance work is necessary. If you would like to meet to discuss the work in more detail, or if you have any questions, please call me at 845-783-5480.



Notice of No Jurisdiction – Article 24 Freshwater Wetlands


The New York State Department of Environmental Conservation (DEC) has reviewed the revised submission that was submitted by ERS Consultants, Inc. on behalf of Blue Arrow Too, LLC, and received on December 22, 2017, for a permit pursuant to Article 24, of the Environmental Conservation Law (ECL), Freshwater Wetlands. The project involves the restoration of an old horse farm, including the installation of a proposed interior gravel drive, construction of a 16,000-square-foot (sq. ft.) indoor arena building, and the construction of a 5,000-sq. ft. maintenance building. Additionally, a site visit by DEC staff found that an interior gravel driveway had been partially constructed on the site without permits from this agency.

The revised plans show that the indoor arena building has been moved outside of the adjacent area of DEC-regulated freshwater wetland Pl-18. The interior gravel driveway is no longer proposed and the maintenance building remains outside of the regulated adjacent area.


A permit pursuant to Article 24 of the ECL, Freshwater Wetlands, is not required. This determination of <u>no jurisdiction</u> was based upon the plan prepared by ERS Consultants, Inc., titled "Wetland Delineation Map Existing Conditions "A" Line and "B/BB" Line," sheet 1 of 1, dated 10/19/16, and last revised 12/06/17. This determination on proposed work is unrelated to the prior work for which tickets were issued.

Please note that a significant portion of the historic track is within the adjacent area of DEC-regulated freshwater wetland PI-18. Routine maintenance of this structure, such as re-grading the surface or filling potholes, does not require a permit. Any significant change such as raising the surface level or changing the material would require a permit.

This notice of no jurisdiction does not alleviate the project sponsor from seeking approvals from other agencies or local governments, as other approvals or permits may be required.




I called Seely and Durland and asked if someone going through training can drive our bus, as in this case, and they said yes as long as I gave permission.

#### O&R: CLEAR AWAY SNOW, ICE TO KEEP GAS SERVICE SAFE

PEARL RIVER, NY Jan. 5, 2018 --- In the aftermath of Thursday's snow storm, O&R urges its customers to take an extra minute for safety's sake to clear snow and ice away from the equipment that delivers natural gas to their homes and businesses.

O&R asks customers to carefully clear snow and ice away from the natural gas regulator and meter as well as any outdoor vents associated with gas equipment. If possible, use a broom instead of a shovel to minimize the chance of damaging the piping. Keeping the equipment and vents clear of ice allow for safe delivery of natural gas.

Natural gas is clean, safe energy that keeps buildings warm and comfortable. But, if the outside equipment that regulates the natural gas flow into these buildings becomes clogged with snow or caked with ice, the effectiveness of that equipment could be impaired and have serious consequences. If building meters and regulators become covered completely with ice, customers should immediately call O&R to free the equipment as encasement in ice can create a dangerous situation. The call is part of the service O&R provides and is at no cost to the customer.


In addition, it is very important that fuel burning appliances are vented to the outdoors where the products of combustion can be safely expelled after the gas has been burned. Blocked appliance intake and exhaust vents can cause accumulation of dangerous carbon monoxide fumes in buildings.

Carbon monoxide detectors are a useful product in alerting when carbon monoxide is accidentally being produced by appliances and escaping into the inside of the house. But, the very best prevention is to be sure all appliances are operating correctly, vent pipes are in place and exhaust is freely flowing up the chimney flue to the outdoors.

O&R also warns that snowplowing and snow dumping operations close to the natural gas equipment increase the risk of damage. O&R urges snow removal operations to dump and pile plowed snow away from O&R natural gas equipment.

If you smell natural gas, leave the area immediately and, from a safe location, call O&R's Gas Emergency Hotline 1-800-533-5325. Also, call if you suspect that natural gas equipment has been damaged or that a natural gas appliance is malfunctioning.

And, no matter what fuel you burn in your heating appliances --- and your fireplace --- if you have flu-like symptoms or headaches that only happen when you are in your home, immediately seek medical attention and



have your appliances and chimney checked for proper venting of products of combustion as those symptoms could be signs of carbon monoxide poisoning.

Look forward to working with you.




