

PLAN YOUR MEALS & SHOP SMART

MEAL PREP

- Chop, pre-cook, and/or freeze items right when you get home from the store. This makes it easy to throw a meal together later in the week.



To all Orange County licensed solid waste haulers;

As you are aware, per Local Law No. 2 of 1989, solid waste generators are *required* to source separate recyclable commodities. To provide a clarification on the accepted materials at Orange County Transfer Stations in effort to reduce contaminated loads of recycling attached you will see a flyer on Single Stream Recycling that we have made available to the public.

In addition to a reminder on what is accepted, we also wish to remind you on what is *NOT* accepted in Single Stream or the Paper/Cardboard Stream. Unacceptable materials are as follows:

Non-recyclable paper, including dirty, wet OCC, wax boxes, laminated paper, soiled paper, trash, Styrofoam©, any kind of plastic bags or film, hoses & tanglers, and trash.

Per our letter emailed to all licensed waste haulers on 2019.1.29, each time we receive problem loads, we will inform you. To ensure compliance, we <u>highly recommended</u> that you contact and distribute this informational guide to your clients. Also, if you feel one or more of your clients may need any additional outreach, e.g. a meeting or presentation on improving our recycling habits, please do not hesitate to contact me. 

Happy Spring! Hope you had a great winter and are looking forward to all that Spring brings!

Did you know: Resilience Information

Did you know that the Gateway features information on Climate Change and Resilience, including incremental sea level rise projections and coastal hazards? Here is a map viewer with some of the information available pre-loaded:

Resilience When you open this view you will see in the legend that one of the layers (Flood Hazard Zones [FEMA]) has a greyed checkmark in the checkbox, this means this layer is "zoom-layered", which means it will become visible when you zoom in closer. The legend provides some useful tools like changing the order of how layers are drawn, making them more or less visible, changing the transparency so that you can see through layers either to the underlying basemap or to data that is layered underneath and if there's a book icon, then that means we're using that layer in one of our stories and clicking on that icon will open up the story to where we're using that layer.

Clicking on objects in the view will open a "call-out" box, this will provide information on the area, point or the line segment you clicked, if there is more than one object where you clicked (often the case) you can get to the information for each object by using the arrows at the bottom right corner of the call-out box. You will also notice in this view that NY Rising Planning Areas are included, you can get to the plans in for these areas by, again, clicking in the area, using the arrows in the bottom right, click to the box that is titled "NY Rising Community Reconstruction Planning Boundaries", RIGHT click on "Final Community Plan" and a pop-up box will appear, select the top choice "Open link in a new tab" by left clicking on it...a new tab will open with the plan document. DOS Coastal Risk Areas are included, you can find out more about these, how they were derived and how we use them by visiting this story DOS Risk Areas

The Gateway Status

As mentioned back in January, are in a bit of a quiet mode. We have completed development of plans for the next phase of Gateway and are working on getting help to realize those plans. We have some great functional additions and new applications built off the Gateway base, I'll be able to share some of these later in the year. We have transitioned to a new cloud server which provides more stability for the platform, you should be noticing this as well as you use the Gateway, please do not hesitate to contact me should you run into performance issues. We are working on a new Story that will accompany the South Shore Estuary Reserve Focus Page which will be ready in late spring! There are quite a few other exciting things in the works which will result in a real growth year for the Gateway, so stay tuned!

Gateway Metrics

We had a few arbitrary benchmarks that seem important to share with you. On March 20th, with a visit from a user in Finland, making it our 100th visit from a country outside the US and just 2 days ago a user in Barbados visited us bringing us to 101! That's 51.5% of the countries in the world today! An average of 14 countries outside the US visit and an average of 28 states outside of New York visit each month. Sometime last Tuesday, March 26th, the Gateway received its 50,000th visitor since launching on September 29, 2015! Longtime average is now about 1200 user visits each month. As of end of March on Sunday there have been 226,250 pageviews, nearly 650,000 actions and average monthly bounce rate is 12%. It's gratifying for the Team to see the continued use of the Gateway and we all thank you for your continued use and support! We hope you find even more useful uses and information on the Gateway in the coming year!

FREQUENTLY ASKED QUESTIONS FOR USDA FORECLOSURE PROPERTIES

What if I purchase the property and find that it needs repair? Question:

The property is being sold in "as is" condition. USDA will not be responsible for Answer:

any repairs incurred by the successful bidder.

What if there are other liens against the property? Question:

All junior liens (if properly identified by Title Company) are extinguished at time of Answer: sale. The successful bidder would be responsible for satisfying any superior liens in order to obtain clear title.

What is the property worth? Question:

USDA does not disclose appraised value. However, in most instances the Answer:

opening bid is less than appraised value.

Can I view the home? Question: USDA does not have title ownership interest in this property. For liability reasons, Answer:_ the Agency cannot allow access to the property until the successful bidder has paid the balance of the bid price and obtained a deed to the property. Successful bidders will not have legal authority to take possession of the property until such time the balance of the purchase price has been paid and they have obtained a referee or marshal's deed to the property.

What about unpaid taxes? Question:

If not paid by USDA prior to sale, unpaid taxes should be adjusted at closing and Answer:

Since USDA does not own the home, we cannot allow access to any third parties. It is best to use other property as collateral or to have cash resources to complete the sale.

What if I can't close within the 30 days, as required by the Terms of Sale? Question: USDA may be willing to grant a closing extension, depending on circumstances. Answer:

What if I don't want the property after deemed the successful bidder? Question: If failure to close was within the successful bidder's control, then there are consequences such as forfeiture of their 10% down payment (refer to Terms of Sale for more specific information).



NOT Accepted: Refrigerators, Tires, Air Conditioners, Electronics, Latex (water based) Paint, BBQ size Propane tanks, Appliances and Alkaline Batteries (can be thrown in the household trash).

How to Dispose of Latex Paint: Remove the lid, put the paint can in a safe place away from children and animals and let the paint dry out. If there is a large quantity of paint in the can, line a cardboard box with a black garbage bag, pour the paint in the garbage bag and add cheap, clay kitty litter until the paint is solid. Once dried, throw the solid paint in your household trash.



Based upon our review of your inquiry received by this office on February 4, 2019, regarding replacement of a deteriorated 24-inch corrugated metal pipe culvert, the New York State Department of Environmental Conservation (DEC) offers the following comments:

STATE-LISTED SPECIES

DEC has reviewed the State's Natural Heritage records. We have determined that the site is located within or near record(s) of the following state-listed species:

Name	<u>Status</u>	
Timber rattlesnake, Crotalus horridus	Threatened	
Northern long-eared bat, Myotis septentrionalis	Threatened	

A permit is required for the incidental taking of any species identified as "endangered" or "threatened," which can include the removal of habitat. If any tree removal is proposed, a time restriction, with all tree removal taking place between November 1st and March 31st, must be implemented. Staff have determined that the project is not likely to have a significant adverse impact on timber rattlesnake populations and no further review is necessary at this time.

Plant species are not subject to regulation, however, impacts to them may be considered as part of the State Environmental Quality Review (SEQR).

Please note that a project sponsor may not commence site preparation, including tree clearing, until the provisions of SEQR are complied with and all necessary permits are issued for the proposed project.



The absence of data does not necessarily mean that rare or state-listed species, natural communities or other significant habitats do not exist on or adjacent to the proposed site. Rather, our files currently do not contain information which indicates their presence. For most sites, comprehensive field surveys have not been conducted. We cannot provide a definitive statement on the presence or absence of all rare or state-listed species or significant natural communities. Depending on the nature of the project and the conditions at the project site, further information from on-site surveys or other sources may be required to fully assess impacts on biological resources.

PROTECTION OF WATERS

There are no waterbodies that appear on our regulatory maps at the location/project site identified. Therefore, if there is a stream or pond outlet present at the site with year-round flow, it assumes the classification of the watercourse into which it feeds, and a Protection of Waters permit may be required. If there is a stream or pond outlet present at the site that runs intermittently (seasonally), it is not protected, and a Protection of Waters permit is not required.

If a permit is not required, please note, the project sponsor is still responsible for ensuring that work shall not pollute any stream or waterbody. Care shall be taken to stabilize any disturbed areas promptly after construction, and all necessary precautions shall be taken to prevent contamination of the stream or waterbody by silt, sediment, fuels, solvents, lubricants, or any other pollutant associated with the project.

FRESHWATER WETLANDS

The project/site is not within a New York State protected Freshwater Wetland. An Army Corps of Engineers permit may be required pursuant to Section 404 of the Clean Water Act. If a Section 404 permit is required, you will also require a Water Quality Certification pursuant to Section 401 of the Clean Water Act. Issuance of these certifications in NYS has been delegated to the DEC. Please contact the Army Corps of Engineers in New York City, at 917-790-8411, for any permitting they might require.

OTHER

Other permits from this Department or other agencies may be required for projects conducted on this property now or in the future. Also, regulations applicable to the location subject to this determination occasionally are revised and the project sponsor should, therefore, verify the need for permits if the project is delayed or postponed. This determination regarding the need for permits will remain effective for a maximum of one year. Applications may be downloaded from our website at www.dec.ny.gov under "Programs" then "Division of Environmental Permits."


