COUNCILMAN DE ANGELO REPORT

- 1. The Post Report for May 2019 is as follows: Greenwood Lake had 164 calls, the Town outside the Village had 657 calls, Pine Island had 312 calls, the Village of Warwick had 563 calls and the Greenwood Lake Fire District had 60 calls for a total of 1,756 for the month of May.
- 2. The current guests at the Warwick Valley Humane Society are 20 dogs, 83 Adult cats, 28 kittens, 9 rabbits, 2 guinea pigs and 4 mice and all of those animals are up for adoption. On Saturday, June 15th at Winslow Therapeutic Riding Center will be a dinner

dance "Sunset at Winslow" which includes a live silent auction, 50/50, wheelbarrow of cheer, great food and great music. There are only 23 tickets remaining at \$75 per person which can be purchased at sunsetatwinslow.com. On June 23rd they are having their annual "Kitten Shower" from 1:00 p.m. until 3:00 p.m. and it's an open invitation for all. The wish list for that is KMR powdered milk replacer, cotton balls, Pate style canned kitten food, non-auto shut off electric heating pads, small cat beds, small cat dishes, receiving blankets, kitten nursing bottles, kitten toys, tunnels and cubbies. Their gift registry is on Smile Amazon and they ask that you choose them as their charity. It's a very interesting thing that they have every year, they get a lot of gifts and they need all the help that they can get.

COUNCILMAN KOWAL REPORT

1. The weekend before last we had our Great Wawayanda Creek Paddle and about 40 kayaks participated including the Town Supervisor. It was good conditions on the creek, the water was high and everybody got through it in 2 hours, which is great having that many people. It was a great event and it is open for recreation up to Memorial Park. What we can do from here is just regular maintenance and I did have a request from the committee for a few signs with arrows on them for people who aren't familiar with how to get to the creek. We will put them up if the sign shop can supply us with them.

Deputy DPW Commissioner Astorino - Just let me know when you want them.

2. At the Pine Island Park there's lots of things going on over there. I finished Installing the security cameras in time for the new playground equipment arrival and we have a couple of camera reminder signs so people will know they are on security cameras. That's going to start getting installed as soon as the weather permits and the material is applied for the foundation with the priority mulch that they want to have go underneath it. We now have a pickleball court at the Pine Island Park. We restriped one of the courts for pickleball, it's a shorter court, with different kinds of paddles that kind of remind me of ping pong. I will have to look it up and learn some of the rules before I play. I don't know if you need special equipment or not or what you need, but that's all of the things that are going on at the park right now.

Supervisor Sweeton – I'm glad that we got that done and I thank DPW for getting the striping for that. We've had a fair number of requests for that over the years, so it's great and to get people active out there is a super thing. Thank you for your work on the Wawayanda Creek project. I want to remind residents if you are going to do it to be respectful because you're going through some areas where there are backyards of some homes. Please just respect their properties and stay off their properties and be quiet through that area and carry out whatever you carry in and just enjoy yourself. Most of the trip is through pretty pristine area, it's not near any homes but there's a few sections, just be respectful. Thank you again Councilman Kowal for spearheading that.

Councilman Kowal – I want to thank the committee once again for clearing it out. There was a lot of work to do and it was all volunteers. We had a meeting a couple of nights ago

and they are prepared to go out again whenever maintenance is required. They said we own that project so whatever work there is to be done we will do it.

Supervisor Sweeton – Your committee did a great job and you and Geoff Howard were cochairs and the committee worked really hard there were a lot of dedicated folks.

Councilman Kowal – They were enthusiastic about and will continue to do maintenance on it.

COUNCILMAN GERSTNER REPORT

- 1. I would like to thank Deputy Commissioner Roe and the Parks Crew for keeping the fields in great shape out there. They always look good and they did a great job, thank all the guys and girls down there. I was actually down there Thursday night on the pavilion side and it looks great for "Woofstock". They did a good job getting that all cleaned up and it looked good.
- 2. The Spring Recreation is coming to an end. The last soccer game was last week and I would like to thank all of the coaches, referees, families and congratulate all of the players for a good season.
- 3. I would like to congratulate all of the graduates and their families, be safe and wish them well in their future.
- 4. There is going to be an open house at Station #3 which is South Street Extension on Saturday, June 15th at 12 noon. They were formed in 1967 and they've been there 52 years now and they are in need of a new station. The open house is for all of the resident to go down and check it out and they will be giving a presentation. The Commissioners and crews are doing a good job with that.

Supervisor Sweeton – The Mayor and I were invited to preview that and they have a good plan that they laid out, so hopefully the residents will be receptive.

COUNCILMAN SHUBACK REPORT

1. There are culvert repairs throughout the town and Greenwood Lake. The County paved Pulaski Highway also Skinners Road, Calmart did it and did a good job. Mt. SUPERVISORS REPORT

- 1. The Community Preservation Funds for May 2019 was \$83,108.12, so that was a good month there.
- 2. I did receive from the New York State Department of Transportation informing me that this summer they will be resurfacing a section of Route 17A from 1 mile east of Old Tuxedo Road which is where they left off last time in the Town of Warwick to about .8 miles west of Long Meadow Road in the Town of Tuxedo. This work will be done in the construction season this year. The project is limited in scope, so the work will involve placing a 1½ asphalt course and then the restoration of the pavement markings. They will notify us at least two weeks prior to them beginning of when the work will actually start. It is a pretty bad section there, so that's good and that leaves only the little section coming up the mountain from Greenwood Lake that they did not do. Hopefully we can get them to do that as well and then get them to do that section in Florida that they seem to not do. At least there is progress and they continue to do some of it and we appreciate the fact that they do that.
- 3. If you've visited Town Hall you can see that there's some construction going on. The front entrance will continue to be closed probably for at least another week and a half until we get railings installed there. Access will continue through the rear of Town Hall and we are also having some lobby renovation work done thanks to the Justice Court Judge DeAngelo and Judge Barlet secured some funding to have that restored. We

appreciate their efforts there. Be careful as you come into Town Hall and get out to the Clerk's office.

- 4. I would like to wish everyone a Happy Fathers' Day to all the father's out there. Enjoy it and enjoy your families and have a great day.
