COUNCILMAN DE ANGELO REPORT

1. The Post Report for August 2020 is as follows: Greenwood Lake had 146 calls, the Town outside the Village had 536 calls, Pine Island had 278 calls, the Village of Warwick had 492 calls and the Greenwood Lake Fire District had 44 calls for a total of 1,496 for the month of August.

2. The Post Report for September 2020 is as follows: Greenwood Lake had 98 calls, the Town outside the Village had 468 calls, Pine Island had 298 calls, the Village of Warwick had 416 calls and the Greenwood Lake Fire District had 40 calls for a total of 1,320 for the month of September.

3. The Warwick Valley Humane Societies current residents for adoption are 5 dogs, 38 cats,

45 kittens between 4 weeks and 5 months old, 1 rabbit, 3 guinea pigs, 2 pekin male ducks and 1 mouse.

4. Suzyn asked me to advise you that The DEC confirms the epizootic hemorrhagic disease in Putnam and Orange County, but it is not transmissible to humans. New Yorkers are encouraged to report sick or dead deer to the DEC at 845-256-3000. They have been receiving a lot of calls about sick and dead deer foaming at the mouth, so they are referring all calls to the DEC.

5. Because of the COVID-19 shelter protocols continue until further notice with visitor and volunteer restrictions. Adoptions are proceeding by appointment only.

COUNCILMAN KOWAL REPORT

1. On September 26th the Town Board joined me with a bunch of other volunteers we had

an open house up at the Kutz Camp as it was formally known on Bowen Road. It was a nice September day and I think about 200 people showed up to look at the facilities. We have a committee forming to decide which direction we want to go with the facility. Everything up there is in really good shape and we hope that we can find a good use and a good direction to go in. That is what the committee is dedicating themselves to and give a report to the Town Board to find out what it is that we are going to do with it. If you can make it this Saturday at the Pine Island Park, they are going to have a concert "The Fiddle Frenzy" from 2:00 p.m. until 4:00 p.m. We hope to have good weather and they held a concert a few years ago at the high school and they were good. Bring a chair, social distance and bring a mask.

COUNCILMAN GERSTNER REPORT

1. I would like to thank Russ and the committee for doing a great job up there for the open house. You put a lot of work into it and you did a good job. All of the residents came out and it was a nice turn out. It will be great for our future recreation and I can't wait to see what comes of all the studies, it's a good thing.

COUNCILMAN SHUBACK REPORT

1. The Town DPW has been repairing catch basins at the prison property, doing drainage

repairs on East Shore Road, paving on East Shore Road, Sterling Place and Hillside Road, mowing and filling potholes town wide, repairing road edges on Cascade Lake Road and Mt. SUPERVISORS REPORT

1. Today I did get on a call with the President of Orange &Rockland Robert Sanchez along with several members of the Association of Supervisors and Mayors of Orange County to discuss their response to the Isaias Storm. We wanted them to understand some of the frustrations our residents felt and to understand what their process was and why it seemed like there was a lot of uncoordinated activities there. Mr. Sanchez was very gracious and he clearly wanted us to know that this was the second most devastating storm in their history. All of their predictions up to the day of the storm did not predict as severe of a storm as occurred. The winds were estimated to peek at 45 mph and they actually peeked at 65 and 70 mph range and they lost over 200,000 customers in the storm area. We talked about some of the issues with their website, with they have what you call a critical response team that they will place in your municipality to help. We got that person on day three of the event, but we should have had that person the next day after the event hit. We talked about their structure in communications and we are hoping that out of that comes some changes that will make the next response maybe a little smoother for residents. Understand, again it was a very devastating storm that knocked a lot of infrastructure out and so we are just trying to improve communications and response and hopefully we did that. I want to thank O&R for sitting down with us remotely to do that.

2. The Community Preservation Fund receipts for the month of September were \$150,830.93, which brings the total in the fund to \$3,928,726.65, again it was a good receipt month for the Community Preservation.

3. Executive Order 203, if you have been following any of the pandemic responses and some of the events around the country that involved police interactions with public and several cases with the unfortunate deaths of civilians at the hands of police officers. Governor Cuomo ordered an executive order 203 which requires any municipality that has a police department to conduct a review of its policies, specifically examine certain things like use of force policy, procedural justice and several other topics. It charges the Supervisor the Chief Executive Order of the municipality to conduct that review in consultation with stake holders in the community. I have put together a panel of approximately 10 individuals from all portions of our community. The first public meeting of that body will be on October 26th at 6:30 p.m. it will be zoomed and Facebook live out to the public so they can watch it live. We will be able to input some questions that perhaps can be addressed in this process as well. There will probably be a second one of these meetings to be scheduled and at that point a plan needs to be developed to make any changes that comes out of this process and then given out to the public for public comments. Once you consider those comments it is presented to this Board for adoption and it's required to be adopted by April 1st of next year otherwise the State will withhold whatever meager funding it sends to the Town of Warwick. We are prepared to examine all of our policies and all of our policies are taken directly from New York State Department of Criminal Justice, so we feel very comfortable with that. We feel very comfortable that our Police Department does an exceptional job in community policing here in the Town of Warwick, but we can always learn and we want to get the perspective of folks that may have a different opinion and I think we will come out of this with a nice review. Stay tuned for that and we will put the contact information for the zoom meeting on the town's website probably by October 15th. We will also be recording it to go out on our municipal channel too. Again, be aware of that and be aware of the process.

4. The budget is still ongoing, we have a tentative budget that needs to be reduced because we are over the cap. It's our intention to be under the cap and we will work until we get there. I appreciate all of the input from the departments. I think all of their budgets if not flat are only barely up and I congratulate all of the department heads for doing that and understanding the situation we're in with reduced revenues, pandemic issues and all the stuff that's going on. There will be a hearing on the budget Thursday after Election Day.

5. I want to give everyone a COVID update because you've been seeing a lot in the news. I was on a conference call today with the County Executive and other municipal leaders. The message that came out is that schools still seem to be fine since they have

reopened and they seem to be doing a good job. There are upticks in the County and there is one zone that the Governor's Office has put into his new zone containment areas they are not containment zones per say, but they are areas of which further restrictions are now in place. The one in Orange County centers around the Town of Palm Tree and a little bit into Monroe, South Blooming Grove and Woodbury. The Health Department and the State are really watching these areas carefully and monitoring and trying to contain any spread of COVID, but it has up-ticked across the County. So, again while none of the rest of the County at the moment is in a zone per say we do have to be careful, we do have to keep social distancing, we do have to keep wearing our masking, washing our hands and just do what you need to do to keep this thing in check. Dr. Gelman of the Health Department did say clearly that it is the County's recommendation that Senior Centers remain closed until further notice. We have closed ours through this pandemic through the end of October, so we will be extending that most likely until the end of the year. I think that's just very prudent because 85% of the fatalities to COVID have occurred in 65 and older age range, so we certainly do not want to put our seniors in any more risk than they need to be. Brendan Casey of the Emergency Management Center is recommending that municipalities do secure additional PPE. We have a good supply for the Town Hall and our workers and we will continue to secure more so we have plenty in the event a spike does increase. The interesting thing is the uptick in cases seem to in the 18-44-year range, so that means younger people who are perhaps a little more fearless are the ones that are getting it. Just interesting notes and we will keep everybody apprised of that.

6. Journal entries were made with the Comptroller and that's all in order.
