### ENVIRONMENTAL CONSULTANTS REPORT

#### COUNCILMAN DE ANGELO REPORT

1. The Post Report for October 2021 is as follows: Greenwood Lake had 150 calls, the Town outside the Village had 505 calls, Pine Island had 326 calls, the Village of Warwick had 425 calls and the Greenwood Lake Volunteer Ambulance District had 62 calls for a total of 1,468 for the month of October.

2. The Warwick Humane Society is having a groundbreaking ceremony for the new animal shelter on November 30<sup>th</sup>, that's the tentative date.

3. Due to their relocation, they are attempting to keep their numbers as low as possible and still assist the public the best they can. They are unable to accept donation items not listed on their wish list due to lack of storage space at their new temporary location at 48 Ronald Reagan Blvd. Donations, adoptions, redemptions, spay/neuter certificates and all visitors and volunteers will continue by appointment only.

4. Currently they have for adoption 7 dogs, 16 adult cats over a year old, 19 young cats ages 6 months to one year and 30 kittens.

5. They are having their pet photo with Santa this Saturday and Sunday, November 20<sup>th</sup> and 21<sup>st</sup> at Fetch Bar & Grill on Main Street in Warwick from 10:00 a.m. until 12 noon. It's a \$25 cash which includes 3 different poses, children and dress up are welcome and all proceeds benefit the homeless pets for the holiday season.

6. Suzyn asked me to wish everybody a Happy Thanksgiving from everyone at the Humane Society.

7. The Town of Warwick Friendly Visitor Program for the month of October the number of neighbors helped was 31, the number of volunteers helping those neighbors was 40, the total number of services provided by volunteers was 407 and the number of volunteer hours provided were 252. They are having 3 training sessions, Tuesday, November 23<sup>rd</sup> at 10:00 a.m., Tuesday, December 7<sup>th</sup> at 6:00 p.m. and Thursday, December 16<sup>th</sup> at 10:00 a.m. If you are interested in becoming a volunteer you can call the Friendly Visitor Coordinator at 845-986-1124 ext. 400.

Supervisor Sweeton – Again, if residents could pass the word its free to seniors in our town to make sure if they need any simple services rides to doctors, food shopping and visiting you can call 986-1120 ext. 400.

2. The Pine Island Chamber of Commerce is having a tree lighting ceremony on December 1<sup>st</sup> at the Pine Island Park. Keep an eye out for details regarding that, its usually a nice evening, nice to get out and get into the holiday season.

#### **COUNCILMAN SHUBACK REPORT**

1. The Highway Department replaced a 12"x40" culvert pipe on High Hill Avenue, on Cornfield Lane and Meadow Road they rebuilt catch basins, on Conklin Road and Big Island Road they dug roadside ditches, town wide they are mowing roadsides, they are filling potholes town wide with hot mix, they are doing emergency repairs as needed, replacing road signs town wide as needed and mowing and maintaining the town parks. All of the town parks are open Kutz Camp pools are closed and fishing will reopen April 1, 2022

#### **TOWN CLERK'S REPORT**

1. We have a drop off for Toys for Tots in our lobby and the High School is also collecting slightly used sneakers and the two boxes are in the Town Hall Lobby.

#### **SUPERVISORS REPORT**

1. The Community Preservation Fund receipts for October 2021 are \$122,205.85 which brings the current fund balance to \$5,683,593.51, so that was another good month for the Community Preservation Fund.

2. I reported last meeting that we received a letter reporting traffic signal upgrades happening around Orange County. I did get a response back from the DOT because it wasn't clear what they were doing and they are putting transfer switches on all of the traffic lights, so in the event of a power failure they would be able to hookup generators to power the signal lights.

3. I received a letter from New York State Department of Public Service and they just want to make a public announcement due to the amount of people living in Nassau County the county is currently covered by one area code the 516. They are holding a hearing on December 2<sup>nd</sup> remotely, a petition to create a new area code for Nassau County. If that is any interest to anybody living in Warwick it will be on December 2<sup>nd</sup> at 1:00 p.m. and we will post how to access and there is actually one at 1:00 p.m. and 6:00 p.m. we will post it on the towns website so you can see it.

4. I want to remind people of the towns snow policy now that we are approaching

snow season, we just have a prohibition against parking on any town road 24 hours prior to and 24 hours after a snow event. You know when it's coming so make sure your car is off the road, it's especially critical in places like Wickham Village, Kings Estates and Wickham Knolls where it's a little tighter and it allows us to efficiently plow and keep the roads open for you to get where you need to be or an emergency vehicle to reach you. Please be aware of that. Also, if you have someone who plows your driveway, please instruct the plow driver that they can not leave snow on the roadways because it's dangerous for you and your neighbors and its costly because we have to go back and plow those roads. There will be fines issued if your plow driver doesn't clean up after he's plowing your driveway.

5. I also want to wish everyone a Happy Thanksgiving and as Councilman Gerstner mentioned try and get to one of the tree lightings. I know the Village of Warwick and the Fire Department are doing their's the Friday after Thanksgiving at 6:00 p.m. On Saturday night at 6:00 p.m. on Railroad Green the Warwick Gardeners will light the green. Both Florida and Greenwood Lake are holding theirs on the same day December 4<sup>th</sup> and Greenwood Lake's is going to be around 5:30 p.m. and Florida's is around 4:00 p.m. there is a Menorah lighting on the 29<sup>th</sup> in Greenwood Lake and I'm sure there will be one in Warwick as well at Lewis Park. This is also Home for The Holidays this weekend in the Village of Warwick, so come out and support those merchants and there will be horse and buggy rides. Enjoy your Thanksgiving, have a safe and healthy one.

**#R2021-293 SEQR RESOLUTION AUTHORIZING THE FILING OF A NEGATIVE DECLARATION OF LOCAL LAW NO. 4 OF 2021 ENTITLED "AMEND CHAPTER 164 ZONING TO CREATE A NEW OVERLAY ZONE TO RESTRICT THE LOCATION OF CANNABIS DISPENSARIES TO LIMITED COMMERCIAL ZONES"**

Motion Supervisor Sweeton, seconded Councilman Gerstner to adopt the following resolution:

Whereas, the Town Board of the Town of Warwick is the SEQR Lead Agency for conducting the environmental review of a proposed set of Amendments to the Town Zoning Law entitled Local Law No. 4 of 2021 which will apply solely within the Town of Warwick, Orange County, New York, and

Whereas, there are no other involved agencies on this action nor federal agencies pursuant to SEQR, and

Whereas, the Town Board has prepared a Long Environmental Assessment Form (EAF) for this Type I action dated August 19, 2021 through September 2, 2021 including Parts 1, 2 and 3, and

Whereas, the Town Board has reviewed the Criteria for Determining Significance found in 617.7(c) of the SEQR regulations, the probable environmental effects of the action, and has considered such impacts as disclosed in the EAF.

Now Therefore Be It Resolved, that the Town Board adopts the findings and conclusions relating to probable environmental effects contained within the attached EAF and Negative Declaration and authorizes the Town Supervisor to execute the EAF and file the Negative Declaration in accordance with the applicable provisions of law, and

Be It Further Resolved, that the Town Board authorizes the Town Supervisor to take such further steps as might be necessary to discharge the Lead Agency's responsibilities on this action.

Motion Carried (5 Ayes, 0 Nays) Supervisor Sweeton declared this resolution duly adopted.

Discussion: Supervisor Sweeton stated that this is the amendments to Chapter 164 Zoning to create an overlay zone that will restrict the location of cannabis dispensaries to very limited amount of commercial spaces.

**#R2021-294 ADOPT LOCAL LAW NO. 4 OF 2021 ENTITLED "A LOCAL LAW TO AMEND CHAPTER 164 OF THE TOWN ZONING CODE - DESIGNATING ZONES PERMITTING LICENSED CANNABIS DISPENSARIES"**

Motion Supervisor Sweeton, seconded Councilman Gerstner to adopt Local Law No. 4 of 2021 entitled Amending Chapter 164 of the Town Zoning Code designating zones and creating an Overlay Zone in which to permit licensed cannabis dispensaries.

Motion Carried (5 Ayes, 0 Nays) Supervisor Sweeton declared this resolution duly adopted.

**#R2021-295 ADOPT LOCAL LAW NO.5 OF 2021 ENTITLED "OPT OUT OF ONSITE CANNABIS CONSUMPTION SITES" (INTRODUCED AS INTRODUCTORY LOCAL LAW NO. 3)**

Motion Supervisor Sweeton, seconded Councilman Gerstner to adopt a Local Law No.5 of 2021 entitled "Opt Out of Onsite Cannabis Consumption Sites AS REQUIRED BY THE Marijuana Regulations and Taxation Act (MRTA)

Motion Carried (5 Ayes, 0 Nays) Supervisor Sweeton declared this resolution duly adopted.

Discussion: Supervisor Sweeton stated we've taken the position that until the State lays out its regulations for onsite cannabis consumption venues that we would reserve our right to not permit them until such time as we see those regulations and then we can reconsider it. That is a requirement for us to do this under the new legislation before December 31<sup>st</sup>.

It's a good budget, it's a reasonable budget, a conservative budget, but one that funds I think most things that we need to provide and keep our service levels up for residents.

This now brings us up to date with all the legislation that New York State also had incorporated in changing things.

Police Chief McGovern – The advantage to the way we did it with Lexipol is that is a challenge to keep up with all the changes and they do it for us. They alert us and then we have to go in and revamp the policy and those are things in the past that went by the wayside.

Supervisor Sweeton – Another feature of Lexipol is that our Officers get a daily training.

Police Chief McGovern – They get a training with respect to certain topics, important topics and then they get a test at the end and it takes about 3 or 4 minutes each shift for each person, so it keeps everything fresh.

Supervisor Sweeton – We appreciate the hard work to get this done.

Motion Carried (5 Ayes, 0 Nays) Supervisor Sweeton declared this resolution duly adopted.


Discussion: Supervisor Sweeton thanked Officer Helmrich for his service to the town and wished him well on his retirement and hope it all works out.
