Supervisor Sweeton – For the publics information this was brought to our attention by the office of the State Comptroller on a routine visit, that in town law it states that water and sewer rents, which the second hearing is on sewer rents which are the quarterly fees you pay if in a district, should be paid to the Receiver of Taxes. Historically the Town has done a resolution at its re-org meeting where by the Supervisors office being a full-time office as opposed to a part time office has been the collector of sewer and water rents. I did research to go back and found as far back as 1977 that's the way the Town has been doing it. It was pointed out to the Town in 1977 an auditor from the State that the way they were doing it which was appointing a superintendent of water and sewer to collect the rents and that was not appropriate and that's when they made the switch to the Supervisors office. The Town Law Section references that as otherwise modified by law, so the purpose of the hearing tonight is to modify our local law our chapters 127 and 157 to indicate that the Supervisor will be the collector of water and sewer rents. Having said all that, I will open the floor for public comment.

There were no comments for or against this public hearing from the Town Board or the public.
