DISCUSSION: REVOCATION OF 105 DEKAY ROAD

Supervisor Sweeton – Attorney Myrow can you give some direction on how to proceed?

Attorney Myrow – Was the homeowner notified?

Supervisor Sweeton – Yes, a letter was sent via certified mail and it came back unsigned.

Councilman Shuback – Send another letter and if he doesn't show up then revoke his application.

Attorney Myrow – Did he request to be heard?

Supervisor Sweeton – The Board would like to give him another chance.

Councilman Shuback – If he does not show up then we should revoke his application.

PRESENTATION: CHIEF RADER – Thank you Supervisor and Town Board for allowing us some time at the beginning of the meeting to recognize some of the great work performed by our officers over the last couple of months. Every day the officers and dispatchers work around the to ensure the safety of our residents and visitors. Tonight, we will highlight some recent events that we responded to in which our officers went above and beyond the call of duty. We will also recognize the efforts of others outside of the police department that contributed to these recent events.

For our first presentation I would like to recognize Thomas Cunningham. In August of 2022 the Town of Warwick Police Department partnered with the Warwick Prevention Coalition to celebrate National Night Out. The event was very successful. In the early part of 2023 Tom Cunningham came to the police station and volunteered his services to make this year's event an even bigger success. Tom worked tirelessly meeting with local businesses, securing donations and helping out with many of the details needed to host an event that over

2000 people would attend. Many of the extras we had that night came from Tom's own pocket. On behalf of the men and women of the Warwick Police Department and a very grateful community that attended the event on the evening of August 1st. We want to give you this plaque as a symbol of our appreciation.

Thomas Cunningham – Resident – This is not about me; this was about my firsthand experience with a couple of police officers. My wife has caregivers and sometimes when I'm by myself if she were to fall, I couldn't get her up. She's had cancer 4 times and we've been married for 53 years, but it's about those police officers that you have standing over there and not about me. They came and helped me and I really appreciated that.

Police Chief Rader and 1st Sergeant Morley presented a Life Saving award recommended by Sergeant John Harter to Sergeant John Harter, Officer Joseph Kennedy, Officer John Kennedy and Officer Timothy Horton and I would also like to introduce Roman and Michelle Jeter. We are also honored to have the 911 Emergency Communications Deputy Commissioner Greg Schmid and Dispatcher Valerie Starace. First, I would like to present the award to the officers and this commendation is for Life Saving which recognizes the work performed by you on August 2023. On August 19, 2023, Officers received a report of a male in cardiac arrest at a residence on Pine Island Turnpike in the Town of Warwick. Officer John Kennedy, Officer Joseph Kennedy, Officer Timothy Horton and Sergeant John Harter responded. The first arriving officers were on scene within three minutes of the initial call. Upon their arrival CPR was already in progress by the victim's spouse with instructions being given by the Emergency 911 Dispatcher. The responding officers assisted with CPR and immediately set up the portable defibrillator. After delivering two shocks to the victim the officers assisted Warwick EMS with transporting him to St. Anthony's Hospital. The efforts of these officers were responsible to a great degree for the saving of the victim's life. This commendation will be worn on your uniform as prescribed in the department regulations and a copy of the letter will be placed in your personnel file as a permanent record of your commendation. Often the unsung heroes in an emergency are the professionals on the other end of the phone, because of the life saving CPR instructions given by Valerie to Michelle the effects of Romans cardiac arrest were beginning to reverse by his wife. We couldn't recognize a more stressful situation for a family then what was happening at time and because of Valeries professionalism a life was saved that day. We are very proud of the relationship we have with the 911 Center; we work together every day on priority emergencies in this county. At this time, I would like to present Valerie with a bouquet of flowers and also Michelle flowers too.

Gregory Schmid – Deputy Commissioner of 911, Orange County – Calls in Warwick have a special meaning to me. I grew up down the road in Sugar Loaf, I'm a Warwick High School graduate and I started my career in 911 here as a Dispatcher for the Warwick Police Department. Valerie is a great public safety dispatcher, she's a training officer for us at 911, she's done hundreds of hours of training and she has 11 years of experience. She was able to ascertain the location during a very stressful situation, she was able to dispatch the ambulance, initiate CPR with the caller and update the responders of what was going on. This highlights the importance of early 911, early CPR and early access to an AED. She did

a great job and on behalf of the Orange County Department of Emergency Services and County Executive Steve Neuhaus we want to present this to you, congratulations.

Police Chief Rader – Thank you and it gives us extra meaning all the way around when we are able to see the end result of the work that the team did together between the caller right to the trip to the hospital, so thank you all for being here tonight.

Roman Jeter – Resident – I dressed up to show you what I do for a living and what I've dedicated my life to do. I train similar to this with the work that I do, I train with CPR and in fact if any of our fellow airmen go down, we're able to help them. I didn't know that I was going to be the one that needed help, so knowing what it takes to do that work and to keep giving the person a chance. Please understand how great and the fact that I know who helped, thank you.

Police Chief Rader and Sergeant Harter presented a Life Saving award recommended by 1st Sergeant Alton Morley to 1st Sergeant Alton Morley, Sergeant Brian Luthin, Sergeant Michael Kearns, Detective Jason Braiser, Officer Brian Siniscalchi, Officer Russell Sircable and Officer Nicholas Scotto, Jade Calabro, James Perry and Claire Heldrich as well. Once again, we are fortunate to see the end results of the efforts that a team put together in a life saving emergency. Every second counts in an emergency Jade Calabro recognizing that James Perry was in cardiac arrest and began CPR prior to the arrival of the officers. Jades quick thinking and immediate reaction was the start of the reversing effects of James condition and no doubt led to revive him. At this time, I would like to present the awards, this commendation is for Life Saving which recognizes the work performed by you on May of 2023. On May 8, 2023, Officers received a report of a male in cardiac arrest at the Café Dulce on Main Street in the Village of Warwick. 1st Sergeant Alton Morley, Sergeant Brian Luthin, Sergeant Michael Kearns, Detective Jason Brasier, Officer Brian Siniscalchi, Officer Russell Sircable, and Officer Nicholas Scotto. The first arriving officers were on scene within one minute of the call. Upon arrival CPR was already in progress by Jade Calabro, an employee of the café. The responding officers assisted with CPR and immediately set up the portable defibrillator. After delivering two shocks to the victim the officers assisted Warwick EMS with transporting him to St. Anthony's Hospital. The efforts of these officers were responsible to a great degree for the life saving of the victim. This commendation will be worn on your uniform as prescribed in the department regulation and a copy of this letter will be placed in your personnel file as a permanent record of the commendation. I would like to make a note that in Jason's career this is the 3rd time he's received a Life Saving award. I would also like to note that in Sergeant Morley's career this is his 3rd time receiving the Life Saving award. I would also like to present a plaque to Jade Calabro. This is in recognition of your courageous and life saving actions on Monday, May 8, 2023 at the scene where you provided CPR prior to the arrival of first responders. Thanks for your honorable action's professionals were able to revive the person. You went above and beyond your obligation as a citizen for the greater good of your community.

Mayor Newhard – Men extraordinary work as usual, thank you. Thank you for everything you do for us, but Jade thank you. There's a lot of activity in our village and people are coming and going and you never know what's going to come through your doors especially

when you work in a café as active and as busy as Café Dulce. We wanted to add onto this recognition also a recognition from our village and it simply says, on behalf of the Mayors Office and the Board of Trustees of the Village of Warwick it is my honor to acknowledge Jade Calabro for your extraordinary act of courage, quick thinking and selflessness. You are hereby acknowledged this certificate recognition on this day the 14th of September 2023, Jade congratulations.

Police Chief Rader – Tonight we are privileged to have Mr. Perry here to be with us from that day forward.

Mr. Perry – Resident – It's an honor to be here today. These gentlemen saved my life and I almost died. I just wanted to thank them, each one of them and shake their hands. I've never been more honored in my life, I love this police department, I love the Mayor and I enjoy being here today, thank you.

Police Chief Rader and Sergeant Harter presented the Excellent Police Duty award recommended by myself to 1st Sergeant Alton Morley, Sergeant Brian Luthin, Sergeant Michael Kearns, Officer Kyle Smith, Officer Brian Siniscalchi and Officer Nicholas Scotto and I would also ask Ray, Kaitlin and Lillian Scimeca to come up here please. The event that I'm about to describe is going to go a little bit deeper in detail then we normally do, but it's important that we all understand not only what unfolded but the individual actions of each officer that ultimately led to a successful outcome. While it's impossible to train for every possible situation we face the responding officers work seamlessly on several different levels in a life and death situation to the best possible outcome. The call came in near the afternoon shift change there were another 10 officers that later responded and detectives that were able to help at the scene. What we're recognizing tonight will be what I describe that went down with these officers here in under 60 seconds. This commendation is for Excellent Police Duty to recognize the work performed by you in July of 2023. On July 19, 2023 the Town of Warwick Police Department received an initial report that an infant that had suffered a laceration from a dog bite. 1st Sergeant Alton Morley, Sergeant Brian Luthin, Sergeant Michael Kearns, Officer Brian Siniscalchi, Officer Nicholas Scotto and Officer Kyle Smith responded. Officers Smith and Siniscalchi arrived and observed a family member holding an infant who had multiple lacerations to the face and head was bleeding heavily. They observed a large column of smoke rising from the porch area attached to the left side of the residence. They were advised that the dog was still actively attacking the infant's mother. They immediately placed the family member and the infant in their patrol unit and responded to the emergency room at St. Anthony's Hospital. 1st Sergeant Morley, Sergeant Kearns, Sergeant Luthin and Officer Scotto ran immediately to the rear of the residence where they observed an active structure fire and the infant's mother pinned to the floor still being attacked. Officer Scotto deployed his taser and Sergeant Luthin was able to take the injured woman and another family member to a safe area in front of the residence and begin first aid efforts to stop the bleeding. When the dog turned to attack the officers, they were able to quickly stop the attack and prevent further injuries to themselves and to the other family members. The split-second decisions of these officers were responsible for saving of the lives of everyone in the home that afternoon. This commendation will be worn on your uniform as prescribed by the department regulations and a copy of this letter will be placed

in your personnel file as a permanent record of the commendation. I would like to note that this is the 11th time in his career that Sergeant Alton Morley has received an Excellent Police Service award. For Ray and Lilly, Ray we are so happy that you could be here tonight with that adorable daughter of yours. I'm sorry your wife couldn't make it; we did get her a bouquet of flowers that we will give to you as a token of her bravery that day and putting your daughter's life before her own. For your daughter we have some gifts a little toy for her and hopefully it's the first police car that she's ever had.

Raymond Scimeca – Resident – I would just like to say thank you to all of the responding officers and everyone involved that day on the scariest day of our lives. You guys saved my wife and my daughters life, so from the bottom of my heart thank you very much.

Police Chief Rader and 1st Sergeant Morley presented the Excellent Police Duty award recommended by myself to Detective Jason Brasier, Officer Derek Kerstner, Officer Thomas Maslanka, Officer Bruce Barclay, and Dispatcher Michael Finn. In addition to Officer Bruce Barclay who cannot be here Officer Mark Tooma and Officer Brendan Donohue also could not be here tonight. Shift change on July 11th at 3:00 p.m. was similar to every other shift change that we do 3 times a day, 1,095 times a year. It starts with information and equipment from the previous shift being exchanged, officer safety issues are discussed, officers are given instructions of tasks needed in their assigned post or the next 8 hours, emails are read, phone calls returned, work is caught up on, then there's always the conversation, the stories, and certainly making fun of something one of the officers did recently, if we can't figure something out that happened recently we'll go back to something that happened way in the past because we never forget. The Officers then head out on the road to protect the 105 square miles that we have. What's never discussed at shift change is the chance that one of us might not come back for the shift change at 11:00 p.m. at this time, I would like to present the Excellent Police Duty award to recognize the work performed by you in July of 2023. On July 11, 2023 the Town of Warwick Police Department received an initial report of a serious motor vehicle accident in the Pin Street Bowling alley parking lot involving a tractor trailer. All of the officers assigned to the 3-11 shift acknowledged the call with the exception of Officer Jordan Tetreault. The responding units were quickly updated that a police unit was also involved in the collision and that the officer was trapped in the vehicle. Officer Derek Kerstner, Officer Thomas Maslanka, Officer Mark Toom, Officer Bruce Barclay and Officer Brendan Donohue arrived on the scene and were under the direction of Detective Jason Brasier. Critical information was relayed to the Dispatcher's Michael Finn and Kelly Chirico who were already fielding many phone calls while dispatching ambulance and fire units to the scene. The responding officers immediately took the steps necessary to secure a safe scene to allow the fire department and ambulance to perform lifesaving extrication and aid to Officer Tetreault. They also secured an area for the Medi-vac helicopter that landed to transport her to a trauma center. The officers and dispatchers showed professionalism that went above and beyond the call of duty when faced with an incident involving one of our own. A copy of this letter will be placed in your personnel file as a permanent record of the commendation and the award will be worn in accordance with our regulations. I would like to make note that this is the second time in his career that Dispatcher Finn has received the Excellent Police Duty award. I would like to note that this is the fourth time in his career Detective Brasier has received the Excellent Police Duty award. Jordan can you please come

up, before I give this award, I want to take one step backwards. As I mentioned earlier the 911 Dispatcher, we need to honor our own in this call they become nothing short of an octopus when answering the multitude of phone calls, dispatching all emergency services and the whole time being in the dark as to what is really going on, on the other end of a radio. When it's one of our involved the stress reaches the highest levels yet they handled the call that night like they were giving someone directions to an apple orchard. Often in a call when the chaos gets under control, we fail to give them the updates and forget that on the other end they are wondering what is still going on. I want to note again how above and beyond the call of duty and the professionalism Dispatcher Finn and Dispatcher Chirico showed that night. This next award is a commendation for Excellent Police Duty recognizing the work performed by you in July 2023. On July 11, 2023 Officer Jordan Tetreault was assigned to the 3-11 shift and performing routine patrol duties. While patrolling on Route 94 South in the area of the Pin Street Bowling Alley her marked patrol car was broadsided by an out-of-control tractor trailer. The entire vehicle sustained major damage causing Officer Tetreault to be heavily entrapped. That entrapment required and over forty-five-minute extrication by Warwick Fire Department personnel. Throughout the entire time on the scene, the transportation to Westchester Medical Center by medivac and during the hours, weeks and now months since Officer Tetreault has showed courage and bravery when faced with a near death situation. Officer Tetreault exemplifies the definition of a Town of Warwick Police Officer. Jordan this medal will be worn on your uniform once you're back in it and we know that's coming and a copy of this letter of commendation will be in your personnel file. While Jordan is up here, I just want to highlight her dedication to this department. She started as a Part-Time Dispatcher with us, at first, she really wasn't thinking of law enforcement being her full-time career, but she went into the police academy and became a Part-Time Police Officer. She excelled in this department as a part-time police officer and on July 1st after passing the written test with one of the highest scores in our department and also passing the rigorous physical agility test Jordan was appointed a Full-Time Police Officer and then 10 days later into her career she was involved in this accident. Jordan will hold a special place in my heart as the Chief of the department and in the heart of every officer here for her bravery. Thank you, Jordan. In closing I want to thank the Town Board for the time slot that you gave us tonight, I would like to thank all the families who came here to share these honors, but I especially want to thank our entire department for the work that they perform every day.

Supervisor Sweeton – Chief, thank you very much and for the community this is just a small piece of what these men and woman do every single day on our behalf and we will be forever grateful for that service and we thank you and we look forward to some great deeds going forward. Jordan, I can't tell you how exciting it is to see you, not in a wheelchair, not in a hospital bed, so we need you back soon and thank you all. As scintillating as the rest of the night is going to be we are going to take a 5-minute recess so you can leave if you like.

Police Chief Rader – We are going to be doing some light refreshments in the Senior Center for our officers and anyone else who would like to attend.

SUPERVISORS REPORT

1. Town Budget Process is under way, we will deliver a tentative budget to the Clerk the end of September and it will be available in the Clerks office. That budget is not normally adopted, that is a coalition of all of the department's requests and then the Town Board will begin work on whittling that down. We are under a 2% tax cap, we expect to be under it again this year as we have been. The preliminary budget which is generally the one we adopt will be presented in a public hearing sometime in early November and it must be adopted by law by November 20th.

2. Community Preservation Fund receipts for July were \$116,420.83 and for August were \$158,612.06, so both were very robust months for the Community Preservation Fund.

3. I want to mention that we received confirmation from NRCS which is the National Resource Conservation System, a division of the USDA and that is their Farmland Preservation component. We did receive 2 awards of 50% of the value of the Floridale Farm and the McFarland Farms and those are two farms that are in the process to sell their development rights to the town. We will be processing them and closing them in 2024. That will boost us up over 5,000 acres preserved to date.

4. This Sunday the Chosun Taekwondo Youth Leadership Book Sale is happening in Lewis Park, it was postponed from last week, so it's this Sunday from 10-2. Try to come down and support it, it's a great youth training leadership program for young people, in terms of volunteering and public service. If you can come down, they have great books for sale.

5. On September 19th I will be a guest waiter for the Rumshock Veteran's Benefit

being held at the Landmark Inn on Tuesday, September 19th from 7-9 pm. We will serve you your dinner, clean the dishes up and hopefully do a good job and not spill anything on anyone. It will be myself, the mayors and perhaps some state officials' assemblymen and senators. This is a great organization that tries to help Veterans reintegrate into the community and they are trying to build some houses for Veterans in the Port Jervis area, so we would like to support their effort if you could. You can google Rumshock and find out how to get a ticket for that.

6. Journal entries were made with the Comptroller and I did double check them and they were all in order, so I thank her for that.

- Considered a Full Environmental Assessment Form (Full EAF), Part 1, dated 7/11/23;
- After comparing the thresholds contained in 6 NYCRR 617.4 and 5, determined that the proposed project is a Type 1 Action;
- After examining the EAF, determined that there are no other involved and/or federal agencies on the matter; and
- Declared itself Lead Agency for the review of the action; and

Whereas, the Town Board has considered a letter from the Town of Warwick Planning Board, dated August 16, 2023, expressing support for the adoption of the moratorium for the purpose of developing and reviewing possible amendments to the Code of the Town of Warwick, Chapter 164, Zoning, and other Code Chapters, as needed; and

Whereas, the Town Board has prepared a Full Environmental Assessment form (EAF) including part 1, noted above, and EAF parts 2, and 3, dated August 14, 2023, for the action and the probable environmental effects of the action, and has considered such impacts as disclosed in the EAF;

Now Therefore Be It Resolved, that the Town Board hereby adopts the findings and conclusions related to probable environmental effects contained within the attached EAF and negative declaration, and authorizes the Town Supervisor to execute the EAF and file the negative declaration in accordance with the applicable provisions of law including filing with the Town Supervisor, Town Board, and filing a notice of such action in the Environmental Notice Bulletin; and

Be It Further Resolved, that the Town Board authorizes the Town Supervisor to take such further steps as might be necessary to discharge the lead agencies responsibilities on this action.


