Dear Parents and Guardians of Campers,

The Pine Island Recreation Committee is once again sponsoring the Summer Recreation Program at Pine Island Park on Kay Road. The 2018 program runs from Monday, July 2 to Friday, August 10, 2018. Please note there will be no program on Wednesday, July 4th, 2018. The hours are 9:30 a.m. to 2:00 p.m. **This is a 6 week program and there will be no pro-rating for the cost of the program.** The registration fee is \$80.00 for one child, \$150.00 for two children, \$175.00 for three children and \$200.00 for four children for the six week program. Registration is limited to 250 campers. Age requirements for the campers are completed kindergarten through completion of the seventh grade. **After 4:00 p.m. on June 7th through June 14, 2018 Pine Island Fire District residents can e-mail (pineislandipark@gmail.com) the names, number of children and your physical address to register for a spot for Pine Island Recreation. A confirmation number will be sent that guarantees a space for your child/children. After 4:00 p.m. on June 14th Town of Warwick residents can email (pineislandipark@gmail.com) the names and number of children to register for a spot for Pine Island Recreation. Like Pine Island Recreation on Facebook to download the registration form or get them from Warwick Town Website. This form is to be brought to the Park along with a copy of your child's immunization record. Registration will take place from 6:00 p.m. to 7:30 p.m. at Pine Island Park p.m. on Monday, June 18th for the Pine Island Fire District residents and Tuesday, June 19th from 6:00 p.m. to 7:30 p.m. for the residents of the Town of Warwick. As per Orange County Health Department, a copy of your child's immunizations is needed to be kept on file. THIS IS A MUST and there WILL BE NO EXCEPTIONS. REGISTRATION IS NOT COMPLETE UNTIL THE IMMUNIZATION RECORDS HAVE BEEN RECEIVED - NO SPACES WILL BE HELD. Pine Island Recreation will follow all HIPPA regulations.**

Since the hours run through lunch, each child should bring a bag lunch or participate in the food plan program. PLEASE NO GLASS BOTTLES OR GLASS CONTAINERS FOR SAFETY REASONS.

For the program to run safely and smoothly we ask you to follow these guidelines and the attached Rules & Regulations. **NO CHILD IS TO BE DROPPED OFF BEFORE 9:30 a.m.** If you arrive early, be prepared to stay in your car. **Please depart from the park after dropping off and signing in your child/children.** We require a written note if someone other than the parent is picking up your child. On the reverse side of the registration form please list the names and contact numbers for people who can pick up your children besides the parents. Dress children in appropriate clothing and footwear. We are not allowed to apply sunscreen as per Child Safety rules. School rules of conduct apply at the park.

Monday evenings from 6:30 p.m. to 8:00 p.m. is GAME NIGHT, a really terrific *family* event for kids, moms, dads, and teens. Children must be accompanied by a parent.

There will be 3 Wednesday Teen Bowling nights at Pin Street Alley from 9:00 to 11:00 p.m. This event is open to teens through graduating seniors. Reservation of bowling lanes is required by calling Nancy at 406-2923 to reserve a spot by 6:30 p.m. that evening. Groups of 6 or more are requested and reservations are limited to 30 teens. Bowlers must stay in the bowling alley. Parents must pick up their teen by 11:00 p.m. Pine Island Recreation staff is prohibited from giving rides to or from any event. Disruptive behavior will result in being banned from future teen bowling nights.

The Recreation Program is inspected by the Orange County Health Department as per the requirements by New York State. Reports are available at the Warwick Town Hall.

The following is a list of rules of the program that will be provided to all the parents.

1. Children must be a resident of the Town of Warwick.
2. All children who attend Pine Island Recreation must be registered.

A Day Guest is allowed however a permission note from the parents must accompany them. Pine Island Recreation Camper may have 1 (one) unregistered guest once per summer - no guests allowed on field trips or carnival day.

3. Safety rules will be posted and must be followed. Failure to follow rules will result in expulsion from the program following 1 (one) warning.

4. Children may ride their bike to Pine Island Park. Once there, the bicycle must be secured. Once a child leaves the park on their bike they may NOT return.

5. Children are to be dropped off at the Pavilion and the parent/guardian must personally check in and check out with the staff member on attendance duty. This is to ensure "face to face" contact and helps the staff to get to know the children personally and quickly.

Sign in begins at **9:30 a.m.** *CHILDREN MAY NOT BE IN THE PARK BEFORE 9:30 A.M.*

Pine Island Recreation ends at 2:00 p.m. Please be **prompt**. If the child has not been picked up by 2:05 p.m., the emergency contact will be called **and you will incur a \$1.00 per minute per camper late fee starting at 2:05 p.m.**

For safety reasons, during Recreation hours only campers, staff and Pine Island Recreation Committee members are permitted access to Pine Island Park. The tennis courts, walking path, playground and fitness trail will be closed to the public.

7. **The majority of the staff** will be certified in CPR and First Aid. (Substitutes will not necessarily be certified) If an injury requiring more than basic first aid the ambulance will be called. Parents will be responsible for the medical bill should the child need to be taken to the emergency room.

8. In case of rain - Recreation will be cancelled if it is raining steadily at 8:30 a.m. and the forecast prediction calls for continued rain throughout the day.

In the event of a sudden storm - children must be picked up as soon as possible.
