
Supervisor Sweeton – The purpose of this is to clarify in the code what the fines are for not displaying your stickers. If you're going to use your boat on Wickham Lake and you're coming in from the Simpson Lane side of the lake to the boat launch area you are required to get a permit and you get two stickers and a key to the gate. What we've been finding is when our police have gone over there people are passing the key around and having their friends come over to go to the lake to avoid the very modest \$10 fee for a resident. We wanted to make it clear what the fine is so that our police officers are able to issue a violation for that. That's the purpose of the hearing. The result will be a fine of \$25 for the first offense, \$50 for the second occurrence and a revocation of the permit for the third violation. It will be clear and there will be no issues. The fee is modest and it simply goes to the cost of maintaining that park for picking up trash and clearing it out and everything else.

There were no public comments for or against this public hearing by the public or the Town Board.

CLOSE PUBLIC HEARING: Motion Councilman Kowal, seconded Councilman Gerstner that the public hearing be closed subject to written comments accepted for 10 days and no action will take place until the September 12, 2019 meeting.
