
LEGAL NOTICE: The Clerk read the legal notice, which was duly published in the Warwick Valley Dispatch on September 16, 2020. (Copy of this legal notice is printed at the end of these minutes.)

Supervisor Sweeton – This is just the addition of one lot to the Wickham Water District and this is our largest district and it has ample water supply. The addition of another parcel to the district will actually help all of the residents in the district, because now there will be another user helping to share the burden of the cost of the department. The requirement to have this parcel be added to the district is that we receive an engineering report demonstrating that there is ample water for the district and a map showing where it is. It's a lot on Kings Highway just a little north of Prince Street and there is no issue in terms of the ability to serve it. The expense of hooking in and doing what needs to be done to connect to the system will be born by the lot owners so again there will be no cost to the district for the expansion. At this point I will ask any Board Members do you have any questions at all? Then I will open to the public for any public comments. We do have the family here that's hopefully going to do this, so welcome.

Eduardo Coroso – I work for the New York City Police Department and this is my family, my wife Georgina, Omar, Gabriella and Xavier. We are excited to be in Warwick and we are building our dream home here.

Supervisor Sweeton – Welcome to the town and we will be entertaining it and it will be approved at our next meeting, which is two weeks from tonight because we have to leave a little room for public comments if we get any. You will be notified of that.
