ENVIRONMENTAL CONSULTANTS REPORT

COUNCILMAN DE ANGELO REPORT

1. The Post Report for April 2023 is as follows: Greenwood Lake had 117 calls, the Town outside the Village had 426 calls, Pine Island had 245 calls, the Village of Warwick had 486 calls and the Greenwood Lake Volunteer Ambulance District had 42 calls for a total of 1,316 for the month of April.

2. Preparations are underway for the grand re-opening of the new and improved animal shelter along with the 69th Birthday celebration of the Warwick Valley Humane Society. Both will be held on Saturday, May 20th with the official ribbon cutting at 1:00 p.m. tours of the new facility and refreshments will be available from 1:00 to 4:00 p.m. and monetary gifts will be gratefully accepted.

3. Suzyn Barron asked me to report that there was a recent incident with a fox attacking and biting a person on Newport Bridge Road in the Town of Warwick. The Orange County Health Department confirmed the fox was rabid and the person is undergoing post exposure rabies vaccinations.

4. Again, all dogs, cats and ferrets are required to have current rabies vaccines in the State of New York. This law protects the pets and the public.

5. Dog licensing is also mandated by the State and can be obtained at the Town Clerk's Office with proof of rabies vaccination and spay or neuter certificate.

6. The SNR Spay-Neuter-Return certificates are available for cats only in the Town of Warwick for \$25 cash and can be by appointment at the Warwick Valley Humane Society. You can call 845-986-2473 for more information or to make an appointment.

7. They have a wish list and are in need of paper towels, small and large paper plates, Simple Green cleaner, bleach and Equine Pine bedding pellets for litter. These can be dropped off at 48 Public Works Drive between 12 noon and 4:00 p.m.

8. They hope to see you all at the grand re-opening.

9. Town of Warwick Friendly Visitor Program for the month of April the number of neighbors helped was 25, the number of volunteers helping those neighbors was 25, the total number of services provided by volunteers was 283 and the number of volunteer hours provided were 159. They are always in need of volunteers and they are having volunteer training, which is online on Thursday, June 8th at 10:00 a.m. and Tuesday, June 27th at 5:30 p.m. If you are interested you can call 845-986-1124 ext. 400 leave a message and they will contact you.

COUNCILMAN KOWAL REPORT

1. There are quite a few things going on at Mountain Lake Park and I have a whole list here. They have 36 people signed up for the pickleball clinic with a few spaces left and the clinic is starting on May 23rd.

2. As far as the swimming goes remember to get your passes if you want to get the discount before May 31st. After June 1st the discount no longer applies and you will have to pay full price. There are 21 children signed up for swimming lessons the July evening

lessons 5:15 p.m. to 6:00 p.m. are full, but they have room in the morning as well as for August. The signups will stay open for the month of May and please stop by the recreation office at Mountain Lake Park to sign up.

3. The bird walks are continuing and I went on one last month and it was very interesting. You hear these birds all the time and you wonder what they are and the walking encyclopedia for that is Rich VanTieghem a local birder and James VanGelder from the Orange County Audubon Society will lead you around the park, show you where the birds are, what they sound like and where they live. There will be one more bird walk on Wednesday, June 7th at 9:00 a.m., so if you want to go out and learn more about the local bird population and the different kinds of birds, we have here it will be June 7th.

4. The Hudson Highlands Nature Museum had a meeting for three stroller naturalist classes, since you're in a stroller you're fairly small children and they are finding the signs of spring including tadpoles in the lake, birds nesting in the pavilions and wildflowers blooming and you can get some exercise pushing the strollers. I know the trails around the park are very stroller friendly at this time.

5. We have community events at the parks lodge, outside pavilion and theater include events by the local fire department, local Girl Scouts planting flowers at the park, the Cub Scouts fishing derby and a community story shared event a night of showtunes presented by the Warwick Institute of Culture. Keep an eye out on the town website for events and for more information go to mountainlakepark.com or email recreationdirector@townofwarwick.org more information. There are always great things going on up and more being added all the time and just like we thought it would be it's a great asset to the community and we are very lucky we had the opportunity to purchase it.

COUNCILMAN GERSTNER REPORT

The DPW is staying busy repairing catch basins on Jonathan Court, cleaning ditches on Distillery Road, West Ridge Road and Bellvale Lakes Road, took down two trees with O&R on Amity Road, filling potholes with hot mix town-wide, doing vehicle maintenance and emergency repairs as needed, replacing road signs town-wide as needed, hauling 1/4" stone material to stock pile, replaced a curb box on Jersey Avenue and the parks department are mowing and maintaining our parks and doing a great job.

2. All of the parks are open, the fishing pond is open, the Thomas P. Morahan Park Beach is closed and you can contact the Village of Greenwood Lake for information on that.

3. Lastly, I would like to congratulate the Greenwood Lake Fire Department who will be having a parade for their 100th year this Saturday at 12 noon. The streets will probably be closing by 11:00 a.m. for lineup starting on Windermere Avenue and ending at the new fire station.

SUPERVISORS REPORT

1. Recycling, we've had some recent issues with the County and the other transfer stations tightening up on mixed garbage and recycling in loads that are delivered to them. They are starting to fine and charge extra to the haulers, so our hauler Marangi has identified several residents that are either confused or simply just adding trash to their recycling bins. We can't do that going forward, so we are trying to educate residents that it's only recycle material in your recycle bin. You can download our recycle coach app and it will tell you a lot of information, but you can also plug in what you have doubts on what is recyclable or not and it will tell you. We are sending notices to residents that we can identify that have been confused and hopefully get that cleared up because it can't go on and there will be extra charges that will go onto everyone's recycling bill if we can't get this under control. We hope that residents will cooperate with that.

2. The Repair Café next one will be May 20th at the Senior Center behind us from 10:00 a.m. until 2:00 p.m. and that's where you can bring your items that may not be functioning properly that can be repaired, things like lamps, appliances, knives sharpened, and jewelry repairs. There is a suggested donation, they don't charge you except for the parts if they need to get parts for you and that is from 10:00 a.m. until 2:00 p.m. in the Senior Center.

3. We should be closing on our 40th farm next week, the Siegal Farm out in Amity, it's 189 acres and we are excited about that. It brings us that much closer to the 5,000-acre mark preserved and we are looking to wrap that up next week.

4. General Hathorn Day is on May 21st and that is from 4:00 p.m. until 6:00 p.m. and that celebrates General John Hathorn, whose house has been restored to the Old House Stone Inn. They will have reenactments; a little ceremony and it will be fun. That will be on Sunday, May 21st from 4:00 p.m. until 6:00 p.m. on Hathorn Road.

5. I was remiss in not putting it in my report, but the Town Hall roof is going to be replaced on May 22nd is the date we've been given. There will be dumpsters in the parking area closest to the building and it will be roped off. I urge residents to be cautious when the work is underway, but its sorely needed a 30-year-old roof that leaks in two places that we know. We did save some money rejecting the bids originally and rebidding it.

6. Journal entries were made with the Comptroller and they were in order and I

appreciate that.

All the public land that came to us was one parcel originally. We subdivided a couple of pieces, but the deed transfer from the State because we got it for a \$1.00 precludes us from selling or transferring any of it. We have a private entity there that wants to swap us much more productive parkland and it will be a great addition to the park. In return for marginal land that actually connects their parcel to their activities there, so it's a benefit to us but the State is requiring us to request alienation and the only way you do that is through the State Legislature. Senator Skoufis and Assemblyman Brabenec agreed to carry the Home Rule Request. They are helping shepherd it through and hopefully it gets into law and signed by the Governor and allows us to proceed with it and getting a really beautiful piece in return for marginal land.
